- 1 Amending Title 18 (Crimes and Offenses) of the Pennsylvania
- 2 Consolidated Statutes, further providing for cruelty to

- 5 hereby enacts as follows:
- 6 Section 1. Section 5511(q) of Title 18 of the Pennsylvania
- 7 Consolidated Statutes is amended by adding a definition and the
- 8 section is amended by adding a subsection to read:
- 9 § 5511. Cruelty to animals.
- 10 * * *
- 11 (k.1) Live pigeon shoots prohibited. -- A person commits a
- 12 misdemeanor of the third degree if that person:
- (1) Knowingly imports, receives, transports, delivers,
- sells or offers for sale, purchases, breeds, captures or
- 15 confines a pigeon for use at a live pigeon shoot.
- 16 (2) Knowingly owns, operates, organizes, conducts, aids

- 1 <u>or abets the actual operation, organization or conduct of any</u>
- 2 <u>live pigeon shoot.</u>
- 3 (3) Knowingly permits any place under his control or
- 4 possession to be kept or used for a live pigeon shoot.
- 5 (4) Attends a live pigeon shoot, either as a spectator
- 6 <u>or participant.</u>

- 8 (q) Definitions.--As used in this section, the following
- 9 words and phrases shall have the meanings given to them in this
- 10 subsection:

- 12 <u>"Live pigeon shoot." An event involving the release of birds</u>
- 13 from the family Columbidae as targets for the purpose of
- 14 shooting with a firearm.

- 16 Section 2. This act shall take effect in 60 days.
