AN ACT

- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, changing the name of the Department of
- 3 Military and Veterans Affairs; establishing the Department of
- 4 Veterans Affairs, the bureaus within the department and the
- 5 State Veterans Commission; providing for the powers and
- duties of the Department of Veterans Affairs and its bureaus;
- and making conforming amendments and editorial changes.
- 8 The General Assembly of the Commonwealth of Pennsylvania
- 9 hereby enacts as follows:
- 10 Section 1. Section 102 of Title 51 of the Pennsylvania
- 11 Consolidated Statutes is amended to read:
- 12 § 102. Definitions.
- 13 Subject to additional definitions contained in subsequent
- 14 provisions of this title which are applicable to specific
- 15 provisions of this title, the following words and phrases when
- 16 used in this title shall have, unless the context clearly
- 17 indicates otherwise, the meanings given to them in this section:
- 18 "Armory." Land, buildings and fixtures used for housing
- 19 elements of the Pennsylvania military forces.
- 20 "Department." The Department of Military [and Veterans]

- 1 Affairs of the Commonwealth.
- 2 "National Defense Act." The act of Congress, entitled "An
- 3 act for making further and more effectual provisions for the
- 4 National Defense and for other purposes, approved June 3, 1916,
- 5 its amendments and supplements.
- 6 "National Guard of the United States." The Army National
- 7 Guard of the United States and the Air National Guard of the
- 8 United States.
- 9 "Officer." Commissioned or warrant officer.
- 10 "Order." General or special order, oral or written, whether
- 11 issued pursuant to State or Federal authority.
- 12 "Pennsylvania Guard." Those organized units of the
- 13 Pennsylvania military forces which are not Federally recognized
- 14 or which serve under the authority of the Governor when the
- 15 Pennsylvania National Guard, in whole or in part, is on extended
- 16 Federal active duty.
- 17 "Pennsylvania military forces." The land, air and sea
- 18 military units organized for the internal security of this
- 19 Commonwealth.
- 20 "Pennsylvania National Guard." The Pennsylvania Army
- 21 National Guard and the Pennsylvania Air National Guard.
- 22 Section 2. Chapter 17 of Title 51 is repealed.
- 23 Section 3. Title 51 is amended by adding a chapter to read:

- 9 § 1801. Definitions.
- 10 The following words and phrases when used in this chapter
- 11 shall have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Commission." The State Veterans Commission established
- 14 under this chapter.
- 15 "Department." The Department of Veterans Affairs of the
- 16 Commonwealth established under this chapter.
- 17 "Secretary." The Secretary of Veterans Affairs of the
- 18 Commonwealth.
- 19 § 1802. Department of Veterans Affairs.
- 20 The Department of Veterans Affairs is hereby established as
- 21 an administrative department within the Executive Department of
- 22 the Commonwealth and is vested with the power and authority as
- 23 set forth in this chapter.
- 24 § 1803. Secretary of Veterans Affairs.
- 25 (a) Appointment. -- The Governor shall nominate in accordance
- 26 with the provisions of the Constitution of Pennsylvania and, by
- 27 and with the advice and consent of a majority of the members
- 28 elected to the Senate, appoint a Secretary of Veterans Affairs.
- 29 (b) Qualifications. -- No person shall be nominated under
- 30 subsection (a) unless the person is a veteran.

- 1 (c) Term.--The Secretary of Veterans Affairs shall serve a
- 2 four-year term and until a successor shall have been appointed
- 3 and qualified.
- 4 (d) Vacancy.--If the office of Secretary of Veterans Affairs
- 5 shall become vacant, the Governor shall fill the vacancy in
- 6 accordance with the provisions of the Constitution of
- 7 Pennsylvania and subsection (a).
- 8 § 1804. Deputy secretaries.
- 9 The secretary shall appoint three deputy secretaries, who
- 10 shall serve at the pleasure of the secretary, to assist the
- 11 secretary in the administration and operation of the department
- 12 as follows:
- 13 (1) Deputy Secretary for Veterans Homes.
- 14 (2) Deputy Secretary for Veterans Programs, Benefits and
- 15 Claims.
- 16 (3) Deputy Secretary for Veterans Administration and
- 17 Personnel.
- 18 § 1805. Bureaus and commissions.
- 19 The following bureaus and commissions are created within the
- 20 department:
- 21 (1) The Bureau of Veterans Homes.
- 22 (2) The Bureau of Veterans Programs, Benefits and
- 23 Claims.
- 24 (3) The Bureau of Administration and Personnel.
- 25 (4) The State Veterans Commission.
- 26 § 1806. Powers and duties of department.
- 27 The department shall have the following powers and duties:
- 28 (1) To administer the laws providing for the payment of
- 29 pensions and relief, for the marking of graves of the
- 30 veterans and for the selection, acquisition and maintenance

- of a State military cemetery.
- 2 (2) To investigate and compile data concerning veterans 3 of the armed forces of the United States, and all State and
- 4 municipal activities relating to veterans.
- 5 (3) To administer veterans pensions and benefits under 6 Chapter 77 (relating to veterans' pensions and benefits).
- 7 (4) To administer the Veterans Emergency Assistance 8 Program established under Chapter 85 (relating to veterans' 9 emergency assistance).
- 10 (5) To administer the Educational Gratuity Program
 11 established under Chapter 87 (relating to Educational
 12 Gratuity Program).
 - (6) To administer the disabled veterans real estate tax exemption under Chapter 89 (relating to disabled veterans' real estate tax exemption.)
 - (7) To recommend to the Governor new legislation and amendments to existing statutes concerning veterans and their activities, for submission to the General Assembly.
 - (8) To cooperate with all departments and agencies of the Commonwealth in the interest of veterans welfare.
- 21 (9) To aid in filing and prosecuting all claims of the 22 Commonwealth's veterans and dependents of veterans under 23 Federal or State statutes.
- 24 (10) To aid in the employment and reemployment of all
 25 veterans honorably discharged from the armed forces of the
 26 United States or their auxiliaries.
- 27 (11) To aid in securing hospitalization, for any veteran 28 requiring medical care, that may be provided by a Federal or 29 State mental or medical or surgical facility specifically 30 provided for veterans or in any other public hospital.

- 1 (12) To aid in the rehabilitation of injured, wounded or
- 2 compensable veterans, or other veterans, in educational
- 3 institutions or vocational training institutions to which
- 4 they may be eligible by statute.
- 5 (13) To cooperate with and advise the Department of
- 6 Education with respect to the establishment of vocational
- 7 training programs, particularly programs suited to war
- 8 casualties, for either day or evening instruction, or both.
- 9 (14) To administer relief provided by the Commonwealth
- 10 for veterans and dependents of veterans.
- 11 (15) To administer the distribution of any compensation
- 12 to veterans or dependents of veterans that has been or may be
- granted by the Commonwealth.
- 14 (16) To investigate the work of other departments of the
- 15 Commonwealth administering laws affecting veterans or
- 16 veterans orphans.
- 17 (17) To investigate, compile and maintain complete and
- 18 accurate data concerning veterans of the armed forces of the
- 19 United States and all State and municipal activities relating
- 20 thereto.
- 21 (18) To compile from the records transmitted from the
- various counties of this Commonwealth, a record of the burial
- 23 places within this Commonwealth of deceased service persons,
- including such information as the secretary deems necessary
- and appropriate.
- 26 (19) To establish an information center, and to
- disseminate regularly to chapters, camps and posts of
- 28 veterans organizations throughout this Commonwealth, such
- information as the secretary shall determine, and to transmit
- to the public press and other media of public information,

- 1 information relative to veterans as may be of public
- 2 interest.
- 3 (20) To submit biannually to the Governor, a report of
- 4 State activities on behalf of veterans.
- 5 (21) To perform other duties in connection with veterans
- 6 that may be referred to the secretary by other departments or
- 7 agencies of the Commonwealth, and to be a clearinghouse for
- 8 all problems related to Pennsylvania veterans and their
- 9 dependents.
- 10 (22) To appoint an executive secretary to the
- 11 commission.
- 12 § 1807. Bureau of Veterans Homes.
- 13 (a) Establishment.--The Bureau of Veterans Homes is hereby
- 14 established as a bureau within the department.
- 15 (b) Powers and duties.--In addition to the powers and duties
- 16 conferred under this chapter, the Deputy Secretary for Veterans
- 17 Homes shall, with the approval of the secretary, have the power
- 18 and duty to:
- 19 (1) Oversee the bureau and make recommendations to the
- 20 secretary regarding the maintenance and operation of veterans
- 21 homes throughout this Commonwealth.
- 22 (2) Appoint a director to administer each veterans home.
- 23 Each director shall be qualified and licensed in this
- 24 Commonwealth as a nursing home administrator. Each director
- shall appoint such officers and employees as may be necessary
- 26 and fix their salaries in conformity with the standards
- 27 established by the Executive Board.
- 28 (3) Accept gifts, grants or payments for the use of each
- veterans home, except that the department may expend Federal
- funds to the extent they are appropriated to the department

- 1 by the General Assembly.
- 2 (4) Establish a schedule of fees to be charged
- 3 residents. The fees shall be based on the level of service or
- 4 care required and the ability of the resident to pay. The
- 5 department shall establish the level of service to be
- 6 provided in accordance with the Federal Department of
- 7 Veterans Affairs standards of nursing and domiciliary care.
- 8 (c) Advisory councils for veterans homes.--
- 9 (1) There is hereby established an advisory council for
- 10 each veterans home operated by the department. Each advisory
- 11 council shall consist of 15 members and the secretary, who
- shall serve ex officio. Twelve of the members shall be
- appointed by the Governor from a list of nominations
- submitted to the secretary by the Pennsylvania War Veterans'
- 15 Council. The president pro tempore of the Senate and the
- 16 Speaker of the House of Representatives shall each appoint
- one member from their respective legislative chamber to serve
- on each council. The remaining member on the advisory council
- 19 shall be selected by the residents of the veterans homes.
- 20 (2) Each member of the councils appointed from the
- 21 General Assembly shall serve for the duration of that session
- of the General Assembly. The eight members appointed by the
- Governor shall serve a term of three years, provided that the
- initial eight members selected by the Governor shall serve as
- follows: three members for one year, three members for two
- 26 years and two members for three years as designated by the
- 27 Governor. Each council shall organize as soon as possible and
- shall annually elect a president, vice president and
- 29 secretary.
- 30 (3) The members appointed by the Governor may be removed

- 1 by the Governor for cause.
- 2 (4) Six members of the council shall constitute a quorum
- for the purpose of conducting the business of the council.
- 4 Each council shall meet at least quarterly and at other times
- 5 at the call of the president.
- 6 (5) Members of each council shall receive no
- 7 compensation for their services but shall receive
- 8 reimbursement for their necessary and proper expenses for
- 9 attendance at meetings.
- 10 (6) Each council shall advise the secretary as to the
- 11 management, operation and the adequacy of facilities and
- 12 services at their respective homes.
- 13 § 1808. Bureau of Veterans Programs, Benefits and Claims.
- 14 (a) Establishment. -- The Bureau of Veterans Programs,
- 15 Benefits and Claims is hereby established as a bureau within the
- 16 department. The bureau shall administer all veterans programs,
- 17 except veterans homes, providing for the administration of all
- 18 benefits granted to veterans under the laws of this
- 19 Commonwealth.
- 20 (b) Powers and duties. -- In addition to the powers and duties
- 21 conferred under this chapter, the Deputy Secretary for Veterans
- 22 Programs, Benefits and Claims shall have the power and duty to:
- 23 (1) Oversee the Bureau of Veterans Programs, Benefits
- 24 and Claims and assist veterans and their dependents in making
- 25 claims under Federal or State law.
- 26 (2) Make recommendations to the secretary regarding the
- 27 administration of veterans programs of the Commonwealth.
- 28 (3) Oversee the Scotland School for Veterans' Children.
- 29 § 1809. Bureau of Administration and Personnel.
- 30 (a) Establishment.--The Bureau of Administration and

- 1 Personnel is hereby established as a bureau within the
- 2 department. The bureau shall be responsible for all matters
- 3 relating to the administration of the department.
- 4 (b) Powers and duties.--The Deputy Secretary for
- 5 Administration and Personnel shall have the following powers and
- 6 duties:
- 7 (1) Oversee the Bureau of Administration and Personnel.
- 8 (2) Oversee department personnel.
- 9 (3) Administer the day-to-day operations of the
- 10 department.
- 11 (4) Manage the fiscal affairs of the department.
- 12 (5) Formulate a proposed budget, which shall be approved
- by the secretary, for submission to the Governor.
- 14 (6) Make recommendations to the secretary regarding the
- operations of the department.
- 16 § 1810. State Veterans Commission.
- 17 (a) Establishment.--There is hereby established within the
- 18 department an advisory commission to be known as the State
- 19 Veterans Commission.
- 20 (b) Composition. -- The commission shall be composed of:
- 21 (1) The secretary, ex officio, or his designee.
- 22 (2) The Adjutant General or his designee.
- 23 (3) The State commander, commandant or head, or his
- designee, of each of the following named veterans
- 25 organizations:
- 26 (i) The American Legion.
- 27 (ii) AMVETS.
- 28 (iii) Blinded Veterans Association.
- 29 (iv) Catholic War Veterans of the United States of
- 30 America.

- 1 (v) Disabled American Veterans.
- 2 (vi) Jewish War Veterans of the United States.
- 3 (vii) Marine Corps League.
- 4 (viii) Military Order of the Purple Heart.
- 5 (ix) State Association of County Directors of
- 6 Veterans Affairs.
- 7 (x) Veterans of Foreign Wars of the United States.
- 8 (xi) Veterans of World War I of the United States of 9 America, Inc.
- 10 (xii) Italian-American War Veterans of the United
 11 States, Inc.
- 12 (xiii) The Vietnam Veterans of America, Inc.
- 13 (xiv) American Ex-Prisoners of War.
- 14 (xv) Keystone Paralyzed Veterans Association.
- 15 (4) Four members at large appointed by the Governor from
- a list provided by the Adjutant General, each of whom shall
- 17 be a veteran and a member in good and regular standing of a
- Pennsylvania branch, post, lodge or club of a recognized
- 19 national veterans organization active in this Commonwealth.
- 20 At least one member shall be a female veteran, and at least
- one member shall be a veteran of the Vietnam era. Members at
- 22 large shall serve a term of four years and until a successor
- has been appointed.
- 24 (5) The State Adjutants of the American Legion, the
- Disabled American Veterans (DAV) and the Veterans of Foreign
- 26 Wars (VFW) and the Executive Director of AMVETS as nonvoting
- members.
- 28 (c) Officers.--The commission shall annually elect a
- 29 chairman and vice chairman at the first meeting of the
- 30 commission after October 1. The Deputy Adjutant General for

- 1 Veterans Affairs shall serve as the executive secretary to the
- 2 commission.
- 3 (d) Compensation and expenses.--Members of the commission
- 4 shall receive no compensation for their services but shall
- 5 receive reimbursement for their necessary and proper expenses
- 6 for attendance at meetings.
- 7 (e) Meetings and quorum. -- The commission shall meet upon the
- 8 call of the chairman or the Adjutant General. Nine members of
- 9 the commission shall constitute a quorum.
- 10 (f) Declared vacancies. -- The Governor, upon recommendation
- 11 of the Adjutant General, shall declare a vacancy to exist
- 12 whenever any member at large fails to attend three consecutive
- 13 meetings without good cause. Any declared vacancy shall be
- 14 filled for the unexpired term.
- 15 (g) General powers and duties. -- The commission shall advise
- 16 the secretary and the department on all matters pertaining to
- 17 the status, welfare, benefits, employment and support of
- 18 veterans and veterans programs in this Commonwealth and shall
- 19 perform such other functions as are provided by law.
- 20 (h) Specific powers and duties.--The commission shall have
- 21 the following powers and duties:
- 22 (1) Advise the secretary upon such matters as the
- 23 secretary may bring before it.
- 24 (2) Investigate the work of the department and make
- recommendations to it regarding the department's
- 26 administration of the laws providing for the payment of
- 27 pensions and relief, for the marking of graves of veterans
- and for the selection, acquisition and maintenance of a State
- 29 military cemetery.
- 30 (3) Investigate and recommend to the secretary

- legislation for submission to the General Assembly concerning
- veterans and their activities.
- 3 § 1811. Veterans home hall of fame.
- 4 (a) General rule. -- Each veterans home operated by the
- 5 Commonwealth shall establish and dedicate a hall of fame to
- 6 recognize and honor the military achievements of outstanding
- 7 veterans who have completed honorable, active duty military
- 8 service and who reside or resided in the geographic region
- 9 served by the veterans home. The area or space in the veterans
- 10 home dedicated to the hall of fame may be used for other
- 11 purposes.
- 12 (b) Selection of inductees.--The advisory council for each
- 13 veterans home shall, consistent with the guidelines established
- 14 by the commission in subsection (c), nominate eligible veterans
- 15 for induction into the hall of fame by the commission and
- 16 perform such other duties relating to the hall of fame as
- 17 approved by the commission. Any Medal of Honor recipient shall
- 18 be automatically inducted into the hall of fame.
- 19 (c) Oversight. -- The commission shall develop guidelines for
- 20 the halls of fame. The guidelines shall include, but not be
- 21 limited to:
- 22 (1) Eligibility criteria for qualified candidates.
- 23 (2) Procedures for nomination of candidates and
- 24 selection of inductees.
- 25 (3) Ceremonies to officially honor the inductees.
- 26 (4) Manner of recognizing or presenting the inductees in
- the halls of fame.
- 28 (5) Maintenance of the halls of fame.
- 29 (6) Duties of the advisory councils of the veterans
- 30 homes relating to the halls of fame.

- 1 (d) Documentation.--Each eligible veteran or his or her
- 2 representative shall be responsible for obtaining the
- 3 documentation necessary to establish his or her eligibility from
- 4 the National Archives in Washington, DC, or the National
- 5 Personnel Record Center in St. Louis, Missouri.
- 6 (e) Centralized list.--The State Veterans Commission shall
- 7 keep a centralized list of all hall of fame inductees from all
- 8 regional veterans homes.
- 9 § 1812. Application of Administrative Code.
- 10 Except as otherwise provided by law, the department shall be
- 11 subject to all the provisions of the act of April 9, 1929
- 12 (P.L.177, No.175), known as The Administrative Code of 1929,
- 13 which apply generally to administrative departments.
- 14 Section 4. Sections 3201, 7701, 7702, 8501, 8504(b), 8505,
- 15 8701, 8702(a) and (b), 8703(b) and (c), 8901, 8902, 8903, 8904,
- 16 8905, 9102(a) and (b) and 9301(a) of Title 51 are amended to
- 17 read:
- 18 § 3201. Definitions.
- 19 The following words and phrases when used in this chapter
- 20 shall have the meanings given to them in this section unless the
- 21 context clearly indicates otherwise:
- 22 "Agency." The Pennsylvania Higher Education Assistance
- 23 Agency.
- 24 "Approved institution of higher learning." An educational
- 25 institution offering a post-secondary program of education
- 26 located in this Commonwealth and approved by the Pennsylvania
- 27 Higher Education Assistance Agency.
- 28 "Approved program of education." A degree- or certificate-
- 29 granting curriculum or course of study to be pursued on a full-
- 30 time or part-time basis or its equivalent as determined by the

- 1 Pennsylvania Higher Education Assistance Agency, at an approved
- 2 institution of higher learning.
- 3 "Department." The Department of Military [and Veterans]
- 4 Affairs of the Commonwealth.
- 5 "Eligible member." A member of the Pennsylvania National
- 6 Guard who meets the criteria specified in section 3202 (relating
- 7 to eligibility) and who has been awarded a certificate of
- 8 eligibility under section 3203 (relating to certification of
- 9 eligibility).
- 10 "Full-time student." A student enrolled in an approved
- 11 institution of higher learning pursuing an approved program of
- 12 education equal to or greater than 15 credit hours or its
- 13 equivalent recognized by the Pennsylvania Higher Education
- 14 Assistance Agency as a full-time course of study.
- 15 "Part-time student." A student enrolled in an approved
- 16 institution of higher education pursuing an approved program of
- 17 education of less than 15 credit hours or its equivalent
- 18 recognized by the Pennsylvania Higher Education Assistance
- 19 Agency as a part-time course of study.
- 20 "Program." The Educational Assistance Program established in
- 21 this chapter.
- 22 "Qualified resident." An individual who has been a bona fide
- 23 resident of this Commonwealth prior to the time an application
- 24 for a grant is made. The Pennsylvania Higher Education
- 25 Assistance Agency shall make the final decision on whether an
- 26 applicant is a qualified resident.
- 27 § 7701. Blind veteran's pension.
- 28 (a) Definition.--As used in this section the term "blind
- 29 veteran" shall mean any person who served in the military or
- 30 naval forces of the United States, or any woman's organization

- 1 officially connected therewith, at any time, and who gave the
- 2 Commonwealth of Pennsylvania, as his or her place of residence
- 3 at the time of entering the military or naval forces of the
- 4 United States, and who while performing duties connected with
- 5 such service suffered an injury or incurred a disease which
- 6 resulted in blindness to the extent that he or she has 3/60 or
- 7 10/200 or less normal vision. The term "blind veteran" shall not
- 8 include any person separated from the military or naval forces
- 9 of the United States, or any woman's organization officially
- 10 connected therewith, under other than honorable conditions.
- 11 (b) Amount and eligibility.--In addition to any other
- 12 assistance provided by the Commonwealth and in addition to any
- 13 compensation provided by the Federal Government, every blind
- 14 veteran shall be paid a pension of \$150 per month. Applications
- 15 for such pensions shall be made to and in the form prescribed by
- 16 the department. The [Adjutant General] department shall have the
- 17 power, and it shall be [his] the department's duty to determine
- 18 the eligibility of every applicant for a pension, and [his] the
- 19 department's decision in the matter shall be final.
- 20 § 7702. Paralyzed veteran's pension.
- 21 (a) Amount and eligibility. -- In addition to any other
- 22 assistance provided by the Commonwealth and in addition to any
- 23 compensation provided by the Federal Government, every paralyzed
- 24 veteran shall be paid a pension of \$150 per month. Applications
- 25 for the pensions shall be made to and in the form prescribed by
- 26 the department. The [Adjutant General] department shall
- 27 determine the eligibility of every applicant for a pension, and
- 28 [his] the department's decision in the matter shall be final.
- 29 (b) Regulations.--The [Adjutant General] department shall
- 30 promulgate such regulations as may be necessary to implement

- 1 this program.
- 2 (c) Definition.--As used in this section the term "paralyzed
- 3 veteran" means any person who served in the military or naval
- 4 forces of the United States, or any woman's organization
- 5 officially connected therewith, and who gave this Commonwealth
- 6 as his or her place of residence at the time of entering the
- 7 military or naval forces of the United States and who, while
- 8 performing duties connected with such service, suffered an
- 9 injury or incurred a disease which resulted in the loss or loss
- 10 of use of two or more extremities. The term does not include any
- 11 person separated from the military or naval forces of the United
- 12 States, or any woman's organization officially connected
- 13 therewith, under other than honorable conditions.
- 14 § 8501. Definitions.
- 15 The following words and phrases when used in this chapter
- 16 shall have the meanings given to them in this section unless the
- 17 context clearly indicates otherwise:
- 18 ["Commission." The State Veterans' Commission established
- 19 under section 1702 (relating to State Veterans' Commission).]
- 20 "Department." The Department of Veterans Affairs of the
- 21 Commonwealth established under section 1802 (relating to
- 22 Department of Veterans Affairs).
- 23 "Eligible veteran." A former member of the military or naval
- 24 service of the United States, or women's organization officially
- 25 connected therewith, who:
- 26 (1) served during a period of war or armed conflict and
- 27 was honorably discharged from the armed forces;
- 28 (2) died in service or was killed in action during a
- 29 period of war or armed conflict; or
- 30 (3) as a result of peacetime hostile fire or terrorist

- 1 attack as determined by the department, was killed or
- 2 suffered a service-connected disability as certified by the
- 3 United States Veterans' Administration and, if surviving, was
- 4 honorably discharged from the armed forces.
- 5 "Emergency." A sudden or unexpected loss of income due to
- 6 sickness, disability, unemployment or other cause beyond the
- 7 control of the applicant for emergency assistance.
- 8 "Surviving dependents." The following are considered
- 9 surviving dependents of a deceased eligible veteran:
- 10 (1) The unmarried surviving spouse of the deceased
- 11 eligible veteran.
- 12 (2) If there is no unmarried spouse of a deceased
- eligible veteran, the unmarried minor children, children who,
- 14 before attaining the age of 18, became permanently incapable
- of self-support, and children who are less than 23 years of
- 16 age and are pursuing a full-time course of instruction at an
- 17 approved educational institution, provided they were, on the
- death of the eligible veteran, dependent on the eligible
- 19 veteran for more than 50% of the cost of their support.
- 20 (3) If the eligible veteran is not survived by a spouse
- or dependent children, the surviving parents of the eligible
- veteran, provided that, on the date of the eligible veteran's
- death, they were dependent on the veteran for more than 50%
- of the cost of their support.
- 25 § 8504. Amounts of assistance.
- 26 * * *
- 27 (b) Standards.--Subject to the limitation set forth in
- 28 subsection (a), [the State Veterans' Commission shall recommend]
- 29 <u>the department shall establish</u> uniform and equitable standards
- 30 for the amounts of veterans' emergency assistance.

- 3 Any person aggrieved by a decision denying payment of
- 4 veterans' emergency assistance may appeal to the [Adjutant
- 5 General] <u>department</u> under provisions of Title 2 (relating to
- 6 administrative law and procedure).
- 7 § 8701. Definitions.
- 8 The following words and phrases when used in this chapter
- 9 shall have the meanings given to them in this section unless the
- 10 context clearly indicates otherwise:
- 11 ["Commission." The State Veterans' Commission established
- 12 under section 1702 (relating to State Veterans' Commission).]
- 13 "Department." The Department of Veterans Affairs of the
- 14 Commonwealth established under section 1802 (relating to
- 15 <u>Department of Veterans Affairs</u>).
- 16 "Educational institution." Any college or university of the
- 17 State System of Higher Education, a State-aided educational or
- 18 training institution of a secondary or college grade or other
- 19 institution of higher education, a business school, a trade
- 20 school, a hospital school providing training for nurses, an
- 21 institution providing courses in beauty culture, art, radio or

- 29 result of hostile fire or terrorist attack during peacetime
- 30 (as determined by the Department of Military Affairs);

- 3 (3) was honorably discharged from the military or naval
- 4 forces of the United States and certified by the United
- 5 States Veterans' Administration as a 100% disabled veteran as
- 6 a result of service during a period of war or armed conflict

- 8 determined by the Department of Military Affairs) during

- 3 (a) General rule. -- Any citizen or resident of this

- 8 (1) That person has been honorably discharged or

- determine the need of the applicant.

- 19 determinations of need for exemptions from the payment of
- 20 real estate taxes which have been granted in order to
- 21 determine any changes in the economic status of applicants
- bearing upon the guestion of need.
- 23 (4) Certify the name and address and the need for
- 24 exemption from payment of real estate taxes, or termination
- of such need, to the board for the assessment and revision of
- taxes, or similar board for the assessment of taxes, having
- 27 jurisdiction of the assessment of the real property owned
- solely or as an estate by the entirety and occupied as a
- residence by the person seeking the tax exemption granted by
- 30 this chapter.

- 1 § 8905. Appeals.
- 2 Any applicant aggrieved by a determination of the
- 3 [commission] <u>department</u> may appeal that determination [to the
- 4 Adjutant General] under the provisions of Title 2 (relating to
- 5 administrative law and procedure).
- 6 § 9102. Affidavits and acknowledgments by designated officers.
- 7 (a) Designation of certain officers authorized.--Each local
- 8 organization of The American Red Cross, The American Legion,
- 9 Veterans of World War I of the U.S.A., Inc., Veterans of Foreign
- 10 Wars of the United States, Disabled American Veterans, United
- 11 Spanish War Veterans, Regular Veterans Association, Director of
- 12 Veterans Affairs, Jewish War Veterans of the United States, the
- 13 Military Order of the Purple Heart, the Italian American War
- 14 Veterans of the United States, Incorporated, and such other
- 15 similar organizations now or hereafter accredited or recognized
- 16 by the United States Veterans Administration, which supplies
- 17 such aid and assistance to veterans or their dependents, and
- 18 which gratuitously prepares forms for veterans and their
- 19 dependents in connection with their affairs as such before the
- 20 United States, any agency thereof, or the Commonwealth, any

- 5 officer or person is so designated, his name, address and
- 6 official position shall be furnished to the Secretary of the
- 7 Commonwealth, in writing, signed by such designated officer or
- 8 person, accompanied by a certificate of his designation by the
- 9 proper authority of such organization, or of the Adjutant
- 10 General, the Secretary of Veterans Affairs or the State Director
- 11 of Selective Service, as the case may be. Upon receipt of such
- 12 writing and certificate in form as herein provided the Secretary
- 13 of the Commonwealth, with the approval of the Governor, shall
- 14 issue under his hand and seal of his office a certificate of
- 15 appointment to such designated officer or person which shall
- 16 authorize him to take affidavits or acknowledgments of veterans
- 17 and their dependents in connection with their affairs as such
- 18 before the United States, any agency thereof, or the
- 19 Commonwealth, any agency or political subdivision thereof. Such
- 20 authorized officer or person shall exercise the authority
- 21 conferred under the provisions of this section at the pleasure

- 27 § 9301. Reports of annual conventions.
- 28 (a) Printing and distribution by Commonwealth.--Whenever the
- 29 department commanders of the Grand Army of the Republic, the
- 30 United Spanish War Veterans, the Veterans of Foreign Wars of the

- 1 United States, the American Legion, the Disabled American
- 2 Veterans of the World War, the Veterans of World War I of the
- 3 U.S.A., Inc., the American Veterans of World War II (AMVETS),
- 4 Military Order of the Purple Heart, Jewish War Veterans,
- 5 Catholic War Veterans, Inc., The Society of the 28th Division,
- 6 A.E.F., the Marine Corps League and the Italian American War
- 7 Veterans of the United States, Incorporated, shall report to the
- 8 Department of [Property and Supplies] General Services the
- 9 proceedings of the annual encampment or conventions of their
- 10 respective departments, with such general and special orders and
