AN ACT

- 1 Amending Title 4 (Amusements) of the Pennsylvania Consolidated
- 2 Statutes, reenacting provisions relating to transfers from
- 3 State Gaming Fund to Volunteer Fire Company Grant Program.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 1408 of Title 4 of the Pennsylvania
- 7 Consolidated Statutes is reenacted to read:
- 8 § 1408. Transfers from State Gaming Fund.
- 9 (a) Transfer for compulsive problem gambling treatment.--
- 10 Each year, the sum of \$1,500,000 or an amount equal to .001
- 11 multiplied by the total gross terminal revenue of all active and
- 12 operating licensed gaming entities, whichever is greater, shall
- 13 be transferred into the Compulsive Problem Gambling Treatment
- 14 Fund established in section 1509 (relating to compulsive and
- 15 problem gambling program).
- 16 (b) Transfer for Volunteer Fire Company Grant Program. --

- 1 Annually, the sum of \$25,000,000 shall be transferred from the
- 2 State Gaming Fund to the Volunteer Fire Company Grant Program
- 3 established under the act of July 31, 2003 (P.L.73, No.17),
- 4 known as the Volunteer Fire Company and Volunteer Ambulance
- 5 Service Grant Act.
- 6 (c) Local law enforcement grants.--Annually, the sum of
- 7 \$5,000,000 shall be transferred to the board for the purpose of
- 8 issuing grants to local law enforcement agencies to enforce and
- 9 prevent the unlawful operation of slot machines in this
- 10 Commonwealth.
- 11 (d) Annual transfers. -- Annually, the following sums shall be
- 12 transferred from the State Gaming Fund as follows:
- 13 (1) To each county, 80¢ per acre for each acre of land
- in the county for which a payment is made under the act of
- 15 May 17, 1929 (P.L.1798, No.591), referred to as the Forest
- Reserves Municipal Financial Relief Law, or under 34 Pa.C.S.
- § 708 (relating to payments in lieu of taxes).
- 18 (2) To each school district, 80¢ per acre for each acre
- 19 of land in the school district for which a payment is made
- 20 under the Forest Reserves Municipal Financial Relief Law or
- 21 under 34 Pa.C.S. § 708.
- 22 (3) To each township, 80c per acre for each acre of land
- in the township for which a payment is made under the Forest
- 24 Reserves Municipal Financial Relief Law or under 34 Pa.C.S. §
- 25 708.
- 26 (e) Transfer to Property Tax Relief Fund.--Monthly, the
- 27 State Treasurer shall transfer the remaining balance in the
- 28 State Gaming Fund which is not allocated in subsections (a),
- 29 (b), (c) and (d) to the Property Tax Relief Fund established in
- 30 section 1409 (relating to Property Tax Relief Fund).

1 Section 2. This act shall take effect in 60 days.
