- 1 Amending Title 51 (Military Affairs) of the Pennsylvania
- 2 Consolidated Statutes, further providing for certain leaves
- of absence.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 4102(a) of Title 51 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 4102. Leaves of absence for certain government employees.
- 9 (a) Mandatory.--
- 10 (1) All officers and employees of a political
- 11 subdivision, or its instrumentalities, who are members of the
- 12 Pennsylvania National Guard, shall be entitled to leave of
- absence from their respective duties without loss of pay,
- 14 time or efficiency rating on all days during which they
- shall, as members of the Pennsylvania National Guard, be
- 16 engaged in active State duty. All such officers and employees
- 17 shall, in addition, be entitled to leave of absence from

their respective duties without loss of pay, time or

2 efficiency rating on all days not exceeding 15 days in any

one year during which they shall, as members of the

4 Pennsylvania National Guard or as members of any reserve

5 component of the armed forces of the United States, be

6 engaged in training or other military duty under orders

7 authorized by Federal or State law. All such officers and

employees shall, in addition, be entitled to unpaid leave of

9 absence from their respective duties without loss of

seniority or efficiency rating on all days in excess of 15

days per year during which they shall be engaged in training

or other military duty under orders authorized by Federal or

State law up to the maximum cumulative period authorized by

38 U.S.C. Ch. 43 (relating to employment and reemployment

rights of members of the uniformed services).

16 (2) All officers and employees of the Commonwealth or 17 its instrumentalities who are members of the Pennsylvania 18 National Guard shall be entitled to leave of absence from 19 their respective duties without loss of pay, time or 20 efficiency rating on all days during which they shall, as 21 members of the Pennsylvania National Guard, be engaged in 22 active State duty. All such officers and employees shall, in 23 addition, be entitled to leave of absence from their 24 respective duties without loss of pay, time or efficiency 25 rating on all days not exceeding 15 days in any one year 26 during which they shall, as members of the Pennsylvania 27 National Guard or as members of any reserve component of the 28 armed forces of the United States, be engaged in training or 29 other military duty under orders authorized by Federal or State law. In addition, when such officers and employees 30

- shall be ordered <u>involuntarily</u>, or <u>under a Contingency</u>
- 2 Operations Temporary Tour of Active Duty (COTTAD) agreement
- 3 or voluntarily to serve in a combat zone or in response to a
- 4 <u>domestic emergency</u>, to active duty, <u>other than active duty</u>
- 5 <u>for training, for a period of more than 30 consecutive days</u>
- 6 and assigned to duties away from home station and when such
- 7 duty is ordered under 10 U.S.C. § 12301 (relating to Reserve
- 8 components generally), 12302 (relating to Ready Reserve) or
- 9 12304 (relating to Selected Reserve and certain Individual
- 10 Ready Reserve members; order to active duty other than during
- 11 war or national emergency) [, other than active duty for
- training, for a period of 30 or more consecutive days,] or 32
- U.S.C. § 502(f) (relating to required drills and field
- 14 <u>exercises</u>), they shall be entitled to up to 15 days of
- 15 additional military leave of absence in any one year without
- loss of pay, time and efficiency rating. All such officers
- and employees shall, in addition, be entitled to unpaid leave
- 18 of absence from their respective duties without loss of
- 19 seniority or efficiency rating on all days in excess of 30
- 20 days per year during which they shall be engaged in training
- or other military duty under orders authorized by Federal or
- 22 State law up to the maximum cumulative period authorized by
- 23 38 U.S.C. Ch. 43.
