## AN ACT

- 1 Requiring law enforcement officers to wear appropriate safety 2 gear while serving certain warrants.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Municipal
- 7 Police Officer Warrant Service Safety Act.
- 8 Section 2. Declarations.
- 9 The General Assembly declares that it is the public policy of
- 10 this Commonwealth to provide adequate protection to law
- 11 enforcement officers that engage in the high risk service of
- 12 arrest warrants.
- 13 Section 3. Definitions.
- 14 The following words and phrases when used in this act shall

- 1 have the meanings given to them in this section unless the
- 2 context clearly indicates otherwise:
- 3 "High risk warrant of arrest." A warrant of arrest issued
- 4 for a person involved in any of the following instances:
- 5 (1) The person has taken or is likely to take hostages.
- 6 (2) The person has created or is likely to create a
- 7 stand-off with law enforcement by refusing to comply with
- 8 police demands for surrender or use of fortification.
- 9 (3) The person is known to be armed or potentially armed
- 10 and the likelihood of armed resistance is high.
- "Law enforcement officer." A person who by virtue of the
- 12 person's office or public employment is vested by law with a
- 13 duty to maintain public order or to make arrests for offenses,
- 14 whether that duty extends to all offenses or is limited to
- 15 specific offenses.
- 16 Section 4. Required equipment.
- 17 A law enforcement officer or team of officers that executes a
- 18 high risk warrant of arrest shall be equipped with appropriate
- 19 safety gear, including ballistic helmets and body armor.
- 20 Section 10. Effective date.
- 21 This act shall take effect in 60 days.
