1 2 3 4 5 6	Amending the act of March 10, 1949 (P.L.30, No.14), entitled "An act relating to the public school system, including certain provisions applicable as well to private and parochial schools; amending, revising, consolidating and changing the laws relating thereto," providing for background checks of school directors.
7	The General Assembly of the Commonwealth of Pennsylvania
8	hereby enacts as follows:
9	Section 1. The act of March 10, 1949 (P.L.30, No.14), known
10	as the Public School Code of 1949, is amended by adding a
11	section to read:
12	Section 111.1. Background Checks of School Directors(a)
13	This section shall apply to all current and prospective school
14	directors.
15	(b) The Department of Education shall require school
16	directors to submit, pursuant to 18 Pa.C.S. Ch. 91 (relating to
17	criminal history record information), a report of criminal
18	history record information from the Pennsylvania State Police or

1	<u>a statement from the Pennsylvania State Police that the State</u>
2	Police central repository contains no information relating to
3	that person. The criminal history record information shall be
4	limited to that which is disseminated pursuant to 18 Pa.C.S. §
5	9121(b)(2) (relating to general regulations) and shall be no
б	more than one (1) year old. The Department of Education shall
7	determine the time for the filing of the required information.
8	The Department of Education shall maintain a copy of the
9	required information and shall require each school director to
10	produce the original document within fifteen (15) days of
11	providing notice to the school director.
12	(c) Where the school director has not been a resident of
13	this Commonwealth for at least two (2) years immediately
14	preceding the date of appointment or election, the Department of
15	Education shall require the school director to submit a set of
16	fingerprints which may be submitted to the Federal Bureau of
17	Investigation for Federal criminal history record information
18	pursuant to the Federal Bureau of Investigation appropriation of
19	Title II of Public Law 92-544, 28 U.S.C. § 534 or a copy of the
20	Federal criminal history record. The Department of Education
21	shall return the Federal criminal history record to the school
22	director. When the school director provides a copy of the
23	Federal criminal history record, it shall be no more than one
24	(1) year old. The Department of Education shall maintain a copy
25	of the required information. The original Federal criminal
26	history record shall be returned to the school director.
27	(d) The Department of Education shall promulgate regulations
28	necessary to carry out this section. The regulations shall
29	provide for the confidentiality of criminal history record
30	information obtained pursuant to this section.

8 Section 2. This act shall take effect in 60 days.
