AN ACT

- 1 Establishing the Pennsylvania Performance Evaluation Commission 2 and providing for its powers and duties.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. Short title.
- 6 This act shall be known and may be cited as the Performance
- 7 Evaluation Act.
- 8 Section 2. Purpose.
- 9 The General Assembly finds and declares as follows:
- 10 (1) There is the need to continuously evaluate the
- 11 performance of the Commonwealth's programs and policies to
- 12 assure that tax dollars are spent in the most effective and
- 13 efficient manner possible.
- 14 (2) The citizens of this Commonwealth have the right to
- 15 know that State government is meeting their needs in a cost-
- 16 effective manner.

- 1 (3) Agencies of State government must be able to
- demonstrate that their programs are meeting their goals and
- 3 objectives and are having a positive impact on this
- 4 Commonwealth and its citizens by becoming more focused,
- 5 concentrated and intensive in their performance evaluation
- 6 efforts both for the short term and the long term.
- 7 (4) Given the constrained nature of the fiscal resources
- 8 that will be available both now and into the foreseeable
- 9 future, only those programs that prove their worth can be
- 10 considered for continued funding.
- 11 Section 3. Definitions.
- 12 The following words and phrases when used in this act shall
- 13 have the meanings given to them in this section unless the
- 14 context clearly indicates otherwise:
- 15 "Commission." The Pennsylvania Performance Evaluation
- 16 Commission established in section 4.
- 17 Section 4. Establishing the Pennsylvania Performance Evaluation
- 18 Commission.
- 19 The Pennsylvania Performance Evaluation Commission is hereby
- 20 established to develop and implement a comprehensive system of
- 21 performance evaluation.
- 22 Section 5. Membership.
- 23 (a) Members.--The commission shall consist of the following
- 24 members:
- 25 (1) The Secretary of the Budget.
- 26 (2) The Secretary of Administration.
- 27 (3) The State Treasurer.
- 28 (4) The Auditor General.
- 29 (5) The chairman of the Legislative Budget and Finance
- 30 Committee.

- 1 (6) The chairman and the minority chairman of the
- 2 Appropriations Committee of the Senate.
- 3 (7) The chairman and the minority chairman of the
- 4 Appropriations Committee of the House of Representatives.
- 5 (b) Chairman. -- The members of the commission shall elect a
- 6 chairman at their first meeting.
- 7 Section 6. Powers and duties of commission.
- 8 (a) Meetings.--The commission shall meet as frequently as it
- 9 deems appropriate, but at least once during each month. The
- 10 Secretary of the Budget shall be responsible for calling the
- 11 initial meeting of the commission. The initial organizational
- 12 meeting of the commission shall take place within 30 days of the
- 13 effective date of this act.
- 14 (b) Resources.--The commission may utilize the staff and
- 15 resources of the General Assembly, any Commonwealth agency, and
- 16 any public or private institution which receives Commonwealth
- 17 funds. The General Assembly, Commonwealth agencies and public or
- 18 private institutions receiving Commonwealth funds shall provide
- 19 staff and resources as requested at no cost to the commission.
- 20 The commission may use the space, staff and resources of the
- 21 Legislative Budget and Finance Committee to prepare its final
- 22 report.
- 23 (c) Objectives.--The commission shall evaluate the current
- 24 structure and system of performance evaluation in the
- 25 Commonwealth and develop and implement a comprehensive and
- 26 coordinated system of program evaluation that includes
- 27 monitoring, impact assessment, examination of cost effectiveness
- 28 and cost-benefit analysis. In so doing, the commission shall
- 29 take into consideration the effectiveness of the existing
- 30 systems, including:

- 1 (1) Program evaluations.
- 2 (2) Preaudits.
- 3 (3) Program measures.
- 4 (4) Financial audits.
- 5 (5) Budget process.
- 6 (6) Legislative oversight.
- 7 (7) Performance audits.
- 8 (d) Report to General Assembly. -- Within 90 days of the
- 9 effective date of this act, the commission shall identify those
- 10 programs most in need of performance evaluation. Within 360 days
- 11 of the effective date of this act, the commission shall submit
- 12 to the General Assembly a performance evaluation report for each
- 13 of the programs identified above with specific recommendations,
- 14 including whether:
- 15 (1) To continue or discontinue the program.
- 16 (2) To improve its practices and procedures.
- 17 (3) To modify specific program strategies and
- 18 techniques.
- 19 (e) Comprehensive report. -- The commission shall issue to the
- 20 Governor and the General Assembly a comprehensive report no
- 21 later than one year after the effective date of this act
- 22 containing its recommendations for:
- 23 (1) Implementing a systematic means of evaluating
- 24 programs in order to make State government in Pennsylvania
- 25 more effective and cost efficient.
- 26 (2) Expanding the use of existing oversight processes
- and the role of existing oversight agencies.
- 28 (3) Encouraging greater participation of legislative
- 29 committees in the evaluation process.
- 30 (4) Ensuring systematic scheduling of program

- 1 evaluations.
- 2 (5) Encouraging greater use of evaluation findings by
- 3 policy decision makers.
- 4 (f) State Employee Cost Reduction Incentive Program. --Within
- 5 180 days of the effective date of this act, the commission shall
- 6 develop and implement a State Employee Cost Reduction Incentive
- 7 Program of meritorious service awards to State employees who
- 8 propose procedures or ideas which are adopted and which will
- 9 result in eliminating or reducing State expenditures or
- 10 improving operations, provided such proposals are placed in
- 11 effect. In developing and implementing the program, the
- 12 commission shall consider at least all of the following:
- 13 (1) Elements to be included on a prepared suggestion
- form to be completed by State employees.
- 15 (2) Procedures for reviewing and evaluating completed
- 16 suggestion forms.
- 17 (3) Rewards for adopted suggestions that include cash
- 18 awards and/or paid annual leave.
- 19 Section 7. Effective date.
- This act shall take effect immediately.
