AN ACT

Amending Title 42 (Judiciary and Judicial Procedure) of the Pennsylvania Consolidated Statutes, further providing, in 3 criminal proceedings, for no limitation applicable for 4 certain offenses and for limitation period for major sexual 5 offenses. 6 The General Assembly of the Commonwealth of Pennsylvania 7 hereby enacts as follows: 8 Section 1. Section 5551 of Title 42 of the Pennsylvania Consolidated Statutes is amended to read: 10 § 5551. No limitation applicable. 11 A prosecution for the following offenses may be commenced at 12 any time: 13 (1)Murder. 14 (2) Voluntary manslaughter. Conspiracy to commit murder or solicitation to 15 (3)

commit murder if a murder results from the conspiracy or
