AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An 2 act relating to tax reform and State taxation by codifying 3 and enumerating certain subjects of taxation and imposing taxes thereon; providing procedures for the payment, 5 collection, administration and enforcement thereof; providing 6 for tax credits in certain cases; conferring powers and 7 imposing duties upon the Department of Revenue, certain 8 employers, fiduciaries, individuals, persons, corporations and other entities; prescribing crimes, offenses and 9 penalties," further providing for exclusions from sales and 10 11 use tax.
- 12 The General Assembly of the Commonwealth of Pennsylvania
- 13 hereby enacts as follows:
- 14 Section 1. Section 204(56) of the act of March 4, 1971
- 15 (P.L.6, No.2), known as the Tax Reform Code of 1971, added April
- 16 23, 1998 (P.L.239, No.45), is amended and the section is amended
- 17 by adding a clause to read:
- 18 Section 204. Exclusions from Tax. -- The tax imposed by
- 19 section 202 shall not be imposed upon any of the following:

- 2 (56) The sale at retail or use of tangible personal property
- 3 or services used, transferred or consumed in installing or
- 4 repairing equipment or devices designed to assist persons in
- 5 ascending or descending [a stairway] when:
- 6 (i) The equipment or devices are used by a person who, by
- 7 virtue of a physical disability, is unable to ascend or descend
- 8 [stairs] without the aid of such equipment or device.
- 9 (ii) The equipment or device is installed or used in such
- 10 person's place of residence.
- 11 (iii) A physician has certified the physical disability of
- 12 the person in whose residence the equipment or device is
- 13 installed or used.
- 14 * * *
- 15 (67) The sale at retail or use of wheelchairs.
- 16 Section 2. This act shall take effect in 60 days.
