Definitions. 10 (a) Definitions applicable to printing or newspaper advertising laws. -- Subject to additional definitions contained 11 12 in subsequent provisions of this title which are applicable to specific provisions of this title, the following words and 13

- 1 shall have, unless the context clearly indicates otherwise, the

- 4 <u>"Community paper of mass dissemination."</u>
- 5 (1) A printed paper or publication, bearing a title or
- 6 <u>name</u>, and conveying reading or pictorial intelligence of
- 7 passing events, local or general happenings, printing
- 8 regularly or irregularly editorial comment, announcements,
- 9 <u>miscellaneous reading matter, commercial advertising</u>,
- 10 classified advertising, legal advertising and other notices,
- and which has been issued in numbers of four or more pages at
- 12 <u>short intervals, either daily, twice or oftener each week, or</u>
- weekly, continuously during a period of at least six months,
- or as the successor of such a printed paper or publication
- issued during an immediate prior period of at least six
- months, and which has been circulated and distributed from an
- 17 <u>established place of business to the community at large.</u>
- 18 (2) For purposes of this definition, continuous
- 19 <u>publication shall not be deemed interrupted by any</u>
- 20 <u>involuntary suspension of publication resulting from loss</u>,
- 21 destruction, failure or unavailability of operating
- 22 facilities, equipment or personnel from whatever cause, and
- any community paper of mass distribution so affected shall
- 24 not be disqualified to publish official and legal advertising
- 25 <u>in the event that publication is resumed within one week</u>
- 26 after it again becomes possible.
- 27 (3) A community paper of mass dissemination must do one
- 28 <u>of the following:</u>
- 29 <u>(i) Distribute through the United States mail to</u>
- 30 entire local zip codes.

- 4 Section 2. Title 45 is amended by adding a section to read:
- 5 § 311. Use of community papers of mass dissemination.
- 6 (a) General rule. -- Any government unit may, at its
- 7 <u>discretion</u>, <u>authorize</u> <u>publication</u> in a <u>community</u> <u>paper of mass</u>
- 8 <u>dissemination in substitution of publication in a newspaper.</u>
- 9 (b) Construction. -- Nothing in this section alters or affects
- 10 the obligation to publish a legal notice in a legal newspaper.
- 11 Section 3. This act shall take effect in 60 days.
