- 1 Amending Title 23 (Domestic Relations) of the Pennsylvania
 - Consolidated Statutes, further providing for willful failure
- 3 to pay support order.

- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 4354 of the Title 23 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 4354. Willful failure to pay support order.
- 9 (a) Offense defined. -- An individual who willfully fails to
- 10 comply with a support order of a court of this Commonwealth when
- 11 the individual has the financial ability to comply with the
- 12 support order commits [a summary offense] an offense.
- 13 (b) Application. -- This section applies to all support cases,
- 14 whether civil or criminal and whether the defendant is married,
- 15 unmarried, separated or divorced.

- 1 (c) Jurisdiction. -- Exclusive original jurisdiction of a
- 2 proceeding under this section is vested in the courts of common
- 3 pleas of this Commonwealth.
- 4 (d) Grading.--
- 5 (1) Except as otherwise provided for in paragraph (2),
- 6 <u>an offense under this section shall constitute a summary</u>
- 7 offense.
- 8 (2) An offense shall be graded a misdemeanor of the
- 9 <u>third degree if either of the following apply:</u>
- 10 <u>(i) the offense is a second or subsequent offense</u>
- 11 <u>under this section; or</u>
- 12 <u>(ii) the obligor owes support in an amount equal to</u>
- or greater than 12 months of the monthly support
- obligation.
- 15 (E) COSTS AND EXPENSES TO BE BORNE BY INDIVIDUAL. -- AN
- 16 INDIVIDUAL CONVICTED OF AN OFFENSE UNDER THIS SECTION WHO IS
- 17 APPREHENDED OUTSIDE THIS COMMONWEALTH SHALL, IN ADDITION TO ANY

- 18 OTHER SENTENCE IMPOSED, BE SENTENCED TO PAY THE COSTS AND
- 19 EXPENSES OF RENDITION.
- 20 Section 2. This act shall take effect in 60 days.
