AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- 2 Statutes, providing for an Independence National Historical
- 3 Park registration plate; establishing the Independence
- 4 National Historical Park Fund; and further providing for the
- 5 duties of the Department of Community and Economic
- 6 Development.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Title 75 of the Pennsylvania Consolidated
- 10 Statutes is amended by adding a section to read:
- 11 § 1366. Independence National Historical Park plate.
- 12 The department, in consultation with Eastern National and the
- 13 Independence National Historical Park of the United States
- 14 National Park Service, shall design an Independence National
- 15 <u>Historical Park registration plate</u>. <u>Upon application of any</u>
- 16 person, accompanied by a fee of \$35 which shall be in addition
- 17 to the annual registration fee, the department shall issue the
- 18 plate for a passenger car, motor home, trailer or truck with a

- 1 registered gross vehicle weight of not more than 9,000 pounds.
- 2 The Independence National Historical Park Fund shall receive \$15
- 3 <u>of each additional fee for this plate.</u>
- 4 Section 2. Section 1905 of Title 75 is amended by adding a
- 5 subsection to read:
- 6 § 1905. Payments to special funds.
- 7 * * *
- 8 (d) Independence National Historical Park Fund. -- Fifteen
- 9 <u>dollars of each fee received under section 1366 (relating to</u>
- 10 Independence National Historical Park plate) shall be credited
- 11 to the Independence National Historical Park Fund, as follows:
- 12 (1) There is hereby established a special account in the
- 13 Treasury Department which shall be known as the Independence
- 14 National Historical Park Fund. The purpose of the
- 15 <u>Independence National Historical Park Fund is to assist and</u>
- support educational programs sponsored through the park's
- 17 history education center, known as the Independence Park
- 18 Institute, which promotes tourism and educates visitors on
- 19 the founding of this nation at Independence Hall in
- 20 <u>Philadelphia in the Commonwealth.</u>
- 21 (2) All moneys in the Independence National Historical
- 22 Park Fund are hereby appropriated on a continuing basis to
- 23 the Department of Community and Economic Development and may
- 24 <u>be expended for the purposes authorized under this</u>
- 25 subsection.
- 26 (3) Estimates of amounts to be expended under this
- 27 subsection shall be submitted to the Governor by the
- 28 <u>Department of Community and Economic Development for his</u>
- 29 <u>approval.</u>
- 30 (4) The State Treasurer shall not honor any requisition

- 1 for expenditures by the Department of Community and Economic
- 2 Development in excess of estimates approved by the Governor
- or in excess of the amount available for the purposes for 3
- which the requisition was made, whichever is the lesser 4
- 5 amount.
- Section 3. This act shall take effect immediately. 6
