- 1 Amending Title 42 (Judiciary and Judicial Procedure) of the
- 2 Pennsylvania Consolidated Statutes, providing, in
- 3 Pennsylvania Commission on Sentencing, for sentencing
- 4 database.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 42 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 2155.1. Sentencing database.
- 10 (a) General rule. -- The commission shall maintain a database
- 11 of sentencing information which shall be open to public
- 12 <u>inspection and shall be posted on the Internet. The database</u>
- 13 shall be maintained in a format which allows sentencing
- 14 information to be searched at a minimum by criminal offense,
- 15 judge and judicial district.
- 16 (b) Contents of database. -- The database shall contain
- 17 sentencing information which includes, at a minimum:
- 18 (1) The sentence for a conviction for each misdemeanor

2	(2) Whether sentences were imposed consecutively or
3	concurrently.
4	(3) Whether a sentence was within the sentencing
5	guidelines adopted by the commission.
6	(4) The contemporaneous written statement provided by
