## AN ACT

Amending the act of April 28, 1978 (P.L.87, No.41), entitled "An act authorizing the Commonwealth of Pennsylvania, through the 3 Department of Environmental Resources, to enter into such agreements and to acquire such interest as may be necessary to establish, protect and maintain the Appalachian Trail, and providing for the establishment, protection and maintenance 7 of such trail," further providing for actions by municipalities and their powers and duties; AND MAKING 9 EDITORIAL CHANGES. 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows: 12 Section 1. Section 4 of the act of April 28, 1978 (P.L.87, 13 No.41), known as the Pennsylvania Appalachian Trail Act, is 14 amended to read: 15 SECTION 1. THE TITLE AND SECTIONS 3(A) AND 4 OF THE ACT OF 16 APRIL 28, 1978 (P.L.87, NO.41), KNOWN AS THE PENNSYLVANIA APPALACHIAN TRAIL ACT, ARE AMENDED TO READ: 17 18 AN ACT

AUTHORIZING THE COMMONWEALTH OF PENNSYLVANIA, THROUGH THE

- 1 DEPARTMENT OF [ENVIRONMENTAL] <u>CONSERVATION AND NATURAL</u>
- 2 RESOURCES, TO ENTER INTO SUCH AGREEMENTS AND TO ACQUIRE SUCH
- 3 INTEREST AS MAY BE NECESSARY TO ESTABLISH, PROTECT AND
- 4 MAINTAIN THE APPALACHIAN TRAIL, AND PROVIDING FOR THE
- 5 ESTABLISHMENT, PROTECTION AND MAINTENANCE OF SUCH TRAIL.
- 6 SECTION 3. POWERS OF DEPARTMENT.
- 7 (A) THE COMMONWEALTH OF PENNSYLVANIA, THROUGH THE DEPARTMENT
- 8 OF [ENVIRONMENTAL] CONSERVATION AND NATURAL RESOURCES,
- 9 HEREINAFTER REFERRED TO AS THE DEPARTMENT, IS AUTHORIZED
- 10 INDEPENDENT OF ANY ACTION BY A MUNICIPALITY UNDER SECTION 4 TO
- 11 ENTER INTO WRITTEN COOPERATIVE AGREEMENTS WITH POLITICAL
- 12 SUBDIVISIONS, LANDOWNERS, PRIVATE ORGANIZATIONS AND INDIVIDUALS
- 13 AND TO ACQUIRE BY AGREEMENT, GIFT, EMINENT DOMAIN OR PURCHASE,
- 14 LAND, RIGHTS-OF-WAY AND EASEMENTS FOR THE PURPOSE OF
- 15 ESTABLISHING, PROTECTING AND MAINTAINING A WALKING TRAIL RIGHT-
- 16 OF-WAY ACROSS THIS COMMONWEALTH, NOW GENERALLY KNOWN AS THE
- 17 APPALACHIAN TRAIL, UNDER SUCH TERMS AND CONDITIONS, INCLUDING
- 18 PAYMENT BY THE DEPARTMENT IN LIEU OF PROPERTY TAXES ON TRAIL
- 19 LANDS OR PROPERTY SO ACQUIRED OR SUBJECT TO SUCH USE IN
- 20 ACCORDANCE WITH THE ACT OF MAY 17, 1929 (P.L.1798, NO.591)
- 21 REFERRED TO AS THE FOREST RESERVES MUNICIPAL FINANCIAL RELIEF
- 22 LAW, AS SHALL PROTECT THE INTERESTS OF THE ACTUAL OR ADJACENT
- 23 LANDOWNERS, OR LAND USERS AND AS SHALL FURTHER THE PURPOSES OF
- 24 THIS ACT. IN THE EVENT OF ACQUISITION BY EMINENT DOMAIN OF LAND
- 25 OTHER THAN TILLABLE FARMLAND, THE TOTAL AMOUNT OF LAND SO
- 26 ACQUIRED SHALL NOT EXCEED AN AVERAGE OF 125 ACRES PER MILE OF
- 27 TRAIL; AND IN THE EVENT OF ACQUISITION BY EMINENT DOMAIN OF
- 28 TILLABLE FARMLAND, SUCH ACQUISITION OF SUCH LAND SHALL BE
- 29 LIMITED TO A FOOTPATH WITH A WIDTH OF NOT MORE THAN 25 FEET
- 30 ACROSS SUCH LAND UNTIL THE OWNER OF SUCH LAND EVIDENCES PLANS TO

- 1 CONVERT THE LAND TO NONFARMING USE. ANY DEPARTMENT OR AGENCY OF
- 2 THE COMMONWEALTH, OR ANY POLITICAL SUBDIVISION, MAY TRANSFER TO
- 3 THE DEPARTMENT LAND OR RIGHTS IN LAND FOR THESE PURPOSES, ON
- 4 TERMS AND CONDITIONS AS AGREED UPON, OR MAY ENTER INTO AN
- 5 AGREEMENT WITH THE DEPARTMENT PROVIDING FOR THE ESTABLISHMENT
- 6 AND PROTECTION OF THE TRAIL.

- 8 Section 4. Municipalities; powers and duties.
- 9 Political subdivisions, including municipalities as defined
- 10 in the Pennsylvania Municipalities Planning Code, through which
- 11 the Appalachian Trail passes shall have the power and their duty
- 12 shall be to take such action consistent with applicable law, as
- 13 at least an interim measure, to preserve the natural, scenic,
- 14 historic and esthetic values of the trail and to conserve and
- 15 maintain it as a public natural resource. <u>Such action shall</u>
- 16 include, but not be limited to, the adoption, implementation and
- 17 <u>enforcement of zoning ordinances and subdivision and land</u>
- 18 <u>development ordinances as necessary to preserve those values.</u>
- 19 Such municipalities may act hereunder in that section of the
- 20 municipality through which the Appalachian Trail passes without
- 21 zoning the entire municipality as required under section 605 of
- 22 the Pennsylvania Municipalities Planning Code.
- 23 Section 2. This act shall take effect in 60 days.
