- 5 § 1342. Veteran plates and placard.
- 6 (a) Severely disabled veteran plate. -- On the application of
- 7 a veteran whose service-connected disability is certified at
- 8 100% by the service unit of the armed forces in which the
- 9 veteran served or by the United States Veterans' Administration
- 10 or who has a service-connected disability of the type enumerated
- 11 in section 1338 (relating to person with disability plate and
- 12 placard), the department shall issue a special registration
- 13 plate designating the vehicle as belonging to a severely
- 14 disabled veteran. The registration plate shall have a white
- 15 background, shall have blue numbers or letters as the department
- 16 may determine, shall have the words, "disabled veteran," in at
- 17 least ten-point bold type, inscribed in red at the bottom of the
- 18 plate, and shall include the international symbol for access for
- 19 persons with disabilities. Only one special registration plate
- 20 shall be issued to a veteran under this section. It may be used
- 21 only on a passenger car or truck with a registered gross weight
- 22 of not more than [9,000]  $\underline{10,000}$  pounds. In the case of a
- 23 motorcycle, the department shall issue a decal containing the
- 24 international symbol for access for persons with disabilities
- 25 and the words "disabled veteran" for display on the registration
- 26 plate.

- 28 (c) Disabled veteran plates. -- On the application of any
- 29 veteran having a disability certified by the service unit of the
- 30 armed forces in which the veteran served or by the United States

- 1 Veterans' Administration as service-connected, the department
- 2 shall issue a special registration plate designating the vehicle
- 3 as belonging to a disabled veteran. The registration plate shall
- 4 have a white background, shall have numbers or letters as the
- 5 department may determine and shall have the words "disabled
- 6 veteran" in at least ten-point bold type inscribed at the bottom
- 7 of the plate. Only one special registration plate shall be
- 8 issued to a veteran under this section. It may be used only on a
- 9 passenger car or truck with a registered gross weight of not
- 10 more than [9,000] <u>10,000</u> pounds.
- 11 (d) Prisoner of war plate. -- On the application of an ex-
- 12 prisoner of war whose imprisonment while in the service of the
- 13 armed forces of the United States is certified by the
- 14 appropriate branch of the armed forces, the department shall
- 15 issue a special registration plate designating the vehicle as
- 16 belonging to an ex-prisoner of war. The registration plate shall
- 17 contain the letters "POW" and such other numbers or letters as
- 18 the department may determine and shall have the words "prisoner
- 19 of war" in at least ten-point bold type inscribed at the bottom
- 20 of the plate. Only one special registration plate shall be
- 21 issued to an ex-prisoner of war under this subsection. The
- 22 special registration plate may be used only on a passenger car
- 23 or truck with a registered gross weight of not more than [9,000]
- 24 <u>10,000</u> pounds.

- 26 § 1346. Special plates for recipients of Purple Heart.
- 27 Upon application of any person who is a recipient of the
- 28 Purple Heart, the department shall issue to such person a
- 29 special registration plate designating the vehicle so licensed
- 30 as belonging to a person who is a recipient of the Purple Heart.

- 1 A severely disabled veteran, as described in section 1342(a)
- 2 (relating to veteran plates and placard), who is qualified to
- 3 receive a plate under this section may also elect to receive a
- 4 placard under section 1342(b). The special registration plate
- 5 may be used only on a passenger car or truck with a registered
- 6 gross weight of not more than [9,000] 10,000 pounds.
- 7 § 1348. Special plates for Pearl Harbor survivors.
- 8 Upon application of any person who is a survivor of Pearl
- 9 Harbor, accompanied by a fee of \$20 which shall be in addition
- 10 to the annual registration fee and by such documentation as the
- 11 department shall require, the department shall issue to such
- 12 person a special registration plate designating the vehicle so
- 13 licensed as belonging to a person who is a survivor of Pearl
- 14 Harbor. The special registration plate may be used only on a
- 15 passenger car or truck with a registered gross weight of not
- 16 more than [9,000] 10,000 pounds.
- 17 § 1350. Special plates for veterans of Korean War.
- 18 Upon application of any person who is a veteran of the Korean
- 19 War, accompanied by a fee of \$20, which shall be in addition to
- 20 the annual registration fee, and by such documentation as the
- 21 department shall require, the department shall issue to the
- 22 person a special registration plate designating the vehicle so
- 23 licensed as belonging to a person who is a veteran of the Korean
- 24 War. The special registration plate may be used only on a
- 25 passenger car or truck with a registered gross weight of not
- 26 more than [9,000] <u>10,000</u> pounds.
- 27 § 1351. Special plates for veterans of Persian Gulf War.
- 28 Upon application of any person who is a veteran of the
- 29 Persian Gulf War, accompanied by a fee of \$20, which shall be in
- 30 addition to the annual registration fee, and by such

- 1 documentation as the department shall require, the department
- 2 shall issue to the person a special registration plate
- 3 designating the vehicle so licensed as belonging to a person who
- 4 is a veteran of the Persian Gulf War. The special registration
- 5 plate may be used only on a passenger car or truck with a
- 6 registered gross weight of not more than [9,000] 10,000 pounds.
- 7 § 1352. Wild resource conservation plate.
- 8 The department, in consultation with the Wild Resource
- 9 Conservation Board, shall design a special wild resource
- 10 conservation registration plate. Upon application of any person,
- 11 accompanied by a fee of \$35 which shall be in addition to the
- 12 annual registration fee, the department shall issue the plate
- 13 for a passenger car, motor home, trailer or truck with a
- 14 registered gross weight of not more than [9,000] 10,000 pounds.
- 15 The Wild Resource Conservation Fund shall receive \$15 of each
- 16 additional fee for this plate.
- 17 § 1353. Preserve our heritage registration plate.
- 18 The department, in consultation with the Pennsylvania
- 19 Historical and Museum Commission, shall design a special
- 20 preserve our heritage registration plate. Upon receipt of an
- 21 application, accompanied by a fee of \$35 which shall be in
- 22 addition to the annual registration fee, the department shall
- 23 issue the plate for a passenger car, motor home, trailer or
- 24 truck with a registered gross weight of not more than [9,000]
- 25 <u>10,000</u> pounds. The Historical Preservation Fund shall receive
- 26 \$15 of each additional fee for this plate.
- 27 § 1354. Flagship Niagara commemorative registration plate.
- 28 (a) Plate. -- The department, in consultation with the
- 29 Pennsylvania Historical and Museum Commission, shall design a
- 30 Flagship Niagara commemorative registration plate. Upon

- 1 application of any person, accompanied by a fee of \$35 which
- 2 shall be in addition to the annual registration fee, the
- 3 department shall issue the plate for a passenger car, motor
- 4 home, trailer or truck with a registered gross weight of not
- 5 more than [9,000] <u>10,000</u> pounds.
- 6 \* \* \*
- 7 § 1355. Zoological plate.
- 8 The department, in consultation with the Pennsylvania
- 9 Zoological Council, shall design a special zoological
- 10 registration plate. Upon application of any person, accompanied
- 11 by a fee of \$35 which shall be in addition to the annual
- 12 registration fee, the department shall issue the plate for a
- 13 passenger car, motor home, trailer or truck with a registered
- 14 gross weight of not more than [9,000] 10,000 pounds. The
- 15 Zoological Enhancement Fund shall receive \$15 of the fee paid by
- 16 the applicant for the plate.
- 17 § 1356. Special plates for recipients of Expeditionary Forces
- 18 Medal.
- 19 Upon application of any person who is a recipient of the
- 20 Expeditionary Forces Medal, accompanied by a fee of \$20 which
- 21 shall be in addition to the annual registration fee and by such
- 22 documentation as the department shall require, the department
- 23 shall issue to such person a special registration plate
- 24 designating the vehicle so registered as belonging to a person
- 25 who is a recipient of the Expeditionary Forces Medal. The
- 26 special registration plate may be used only on a passenger car
- 27 or truck with a registered gross weight of not more than [9,000]
- 28 <u>10,000</u> pounds.
- 29 § 1357. Special plates for World War II veterans.
- 30 Upon application of any person who is a veteran of World War

- 1 II, accompanied by a fee of \$20 which shall be in addition to
- 2 the annual registration fee and by such documentation as the
- 3 department shall require, the department shall issue to such
- 4 person a special registration plate carrying the symbol of a
- 5 ruptured duck designating the vehicle so registered as belonging
- 6 to a person who is a veteran of World War II. The special
- 7 registration plate may be used only on a passenger car or truck
- 8 with a registered gross weight of not more than [9,000] 10,000
- 9 pounds.
- 10 § 1358. DARE plate.
- 11 The department, in consultation with the Pennsylvania
- 12 Commission on Crime and Delinquency, shall design a special drug
- 13 abuse resistance education (DARE) registration plate which
- 14 utilizes the DARE logo or slogan in the design. Upon application
- 15 of any person, accompanied by a fee of \$35 which shall be in
- 16 addition to the annual registration fee, the department shall
- 17 issue the plate for a passenger car, motor home, trailer or
- 18 truck with a registered gross weight of not more than [9,000]
- 19 <u>10,000</u> pounds. The Drug Abuse Resistance Education Program shall
- 20 receive \$15 of each additional fee for this plate.
- 21 § 1359. Special plates for steelworkers.
- 22 (a) General rule.--Upon application of any person who is a
- 23 steelworker, accompanied by a fee of \$20 which shall be in
- 24 addition to the annual registration fee and by such
- 25 documentation as the department shall require, the department
- 26 shall issue to such person a special registration plate
- 27 designating the vehicle so licensed as belonging to a person who
- 28 is a steelworker. The special registration plate may be used
- 29 only on a passenger car or a truck with a registered gross
- 30 weight of not more than [9,000] <u>10,000</u> pounds. The plate shall

- 1 bear the likeness of the official emblem of the American Iron
- 2 and Steel Institute.

- 4 § 1360. Special plates for veterans of Vietnam Conflict.
- 5 Upon application of any person who is a veteran of the
- 6 Vietnam Conflict as that term is defined for the awarding of the
- 7 Vietnam Service Medal, accompanied by a fee of \$20 in addition
- 8 to the annual registration fee and by such documentation as the
- 9 department shall require, the department shall issue to the
- 10 person a special registration plate designating the vehicle so
- 11 licensed as belonging to a person who is a veteran of the
- 12 Vietnam Conflict. The special registration plate may be used
- 13 only on a passenger car or truck with a registered gross weight

- 15 § 1362. OPERATION IRAQI FREEDOM VETERANS PLATE.
- 16 UPON APPLICATION OF ANY PERSON WHO IS A VETERAN OF THE
- 17 LIBERATION OR OCCUPATION OF IRAQ, ACCOMPANIED BY A FEE OF \$20
- 18 WHICH SHALL BE IN ADDITION TO THE ANNUAL REGISTRATION FEE AND BY
- 19 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT
- 20 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE
- 21 DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A PERSON WHO
- 22 IS A VETERAN OF OPERATION IRAQI FREEDOM. THE SPECIAL
- 23 REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK
- 24 WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 10,000 POUNDS.
- 25 § 1363. OPERATION ENDURING FREEDOM VETERANS PLATE.
- 26 UPON APPLICATION OF ANY PERSON WHO IS A VETERAN OF THE
- 27 LIBERATION OR OCCUPATION OF AFGHANISTAN, ACCOMPANIED BY A FEE OF
- 28 \$20 WHICH SHALL BE IN ADDITION TO THE ANNUAL REGISTRATION FEE
- 29 AND BY DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE
- 30 DEPARTMENT SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION

- 1 PLATE DESIGNATING THE VEHICLE SO LICENSED AS BELONGING TO A
- 2 PERSON WHO IS A VETERAN OF OPERATION ENDURING FREEDOM. THE
- 3 SPECIAL REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR
- 4 OR TRUCK WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 10,000
- 5 POUNDS.
- 6 § 1364. SPECIAL PLATES FOR VETERANS.
- 7 UPON APPLICATION OF ANY PERSON WHO IS AN HONORABLY DISCHARGED
- 8 VETERAN OF THE ARMED FORCES OF THE UNITED STATES OR A RESERVE
- 9 COMPONENT OF THE ARMED FORCES AS DEFINED IN 51 PA.C.S. § 7301
- 10 (RELATING TO DEFINITIONS), ACCOMPANIED BY A FEE OF \$20 WHICH
- 11 SHALL BE IN ADDITION TO THE ANNUAL REGISTRATION FEE AND BY SUCH
- 12 DOCUMENTATION AS THE DEPARTMENT SHALL REQUIRE, THE DEPARTMENT
- 13 SHALL ISSUE TO THE PERSON A SPECIAL REGISTRATION PLATE
- 14 DESIGNATING THE VEHICLE AS BELONGING TO A PERSON WHO IS A
- 15 VETERAN OF THE ARMED FORCES OF THE UNITED STATES. THE SPECIAL
- 16 REGISTRATION PLATE MAY BE USED ONLY ON A PASSENGER CAR OR TRUCK
- 17 <u>WITH A REGISTERED GROSS WEIGHT OF NOT MORE THAN 10,000 POUNDS.</u>
- 18 Section 2. Section 4307 of Title 75 is amended by adding
- 19 subsections to read:
- 20 § 4307. Use and display of illuminated signs.
- 21 \* \* \*
- 22 (f) Food delivery vehicle.--A food delivery vehicle may
- 23 display an illuminated sign which shall be of a department-
- 24 approved size and type designed not to interfere with or unduly
- 25 distract the drivers of other vehicles on the highway. The
- 26 <u>department shall promulgate regulations setting forth the size</u>,
- 27 type and placement of signs approved for use under this
- 28 <u>subsection</u>.
- 29 (g) Definition.--As used in this section, the term "food
- 30 <u>delivery vehicle" means a vehicle engaged in the transportation</u>

- 1 or conveyance of food products or items from their place of
- 2 <u>origin or production to a place of delivery, which vehicle may</u>
- 3 <u>make intermittent stops that are customary in the routine</u>
- 4 conduct of the business for which the transportation occurs.
- 5 Section 3. This act shall take effect in 60 days.
