AN ACT

- 1 Prohibiting use of coercion and undue influence to gain
- 2 participation of special needs persons in certain research;
- 3 and imposing a penalty.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Short title.
- 7 This act shall be known and may be cited as the Research
- 8 Consent Act.
- 9 Section 2. Definitions.
- 10 The following words and phrases when used in this act shall
- 11 have the meanings given to them in this section unless the
- 12 context clearly indicates otherwise:
- 13 "Interaction." Includes communication and interpersonal
- 14 contact between an investigator and a subject.
- 15 "Intervention." Includes physical procedures by which data
- 16 are gathered and manipulations of the subject's environment that
- 17 are performed for research purposes.

- 1 "Investigator." A person conducting research directly or
- 2 indirectly on behalf of any organization conducting
- 3 experimentation upon humans including, but not limited to,
- 4 pharmaceutical companies, universities, hospitals, whether
- 5 public or private, and governmental entities.
- 6 "Poor." An individual whose personal or family income falls
- 7 below two times the poverty level.
- 8 "Private information." Includes individually identifiable
- 9 information about behavior that occurs in a context in which an
- 10 individual can reasonably expect that no observation or
- 11 recording is taking place and individually identifiable
- 12 information provided for specific purposes by an individual
- 13 which the individual can reasonably expect will not be made
- 14 public.
- 15 "Research." A systematic investigation designed to develop
- 16 or contribute to generalized knowledge. The term includes, but
- 17 is not limited to, generalized research, development, testing
- 18 and evaluation.
- 19 "Special needs person." An individual who suffers from a
- 20 developmental disability, is mentally ill or poor, has substance
- 21 abuse intervention issues or has been convicted of a felony and
- 22 served time in prison as a result of committing the felony.
- 23 "Subject." A living individual about whom an investigator,
- 24 whether professional or student, conducting research obtains:
- 25 (1) data through intervention or interaction with the
- 26 individual; or
- 27 (2) identifiable private information.
- 28 Section 3. Undue influence and coercion prohibited.
- 29 No investigator may involve a special needs individual as a
- 30 subject in research unless the investigator has obtained the

- 1 informed consent of the subject or the subject's legally
- 2 authorized representative in accordance with the provisions of
- 3 this act. An investigator shall seek consent only under
- 4 circumstances that provide the prospective subject or
- 5 representative sufficient opportunity to consider whether or not
- 6 to participate and minimize the possibility of coercion or undue
- 7 influence. Information given to the subject or representative
- 8 shall be in language understandable to the subject or
- 9 representative. No consent or consent form, whether oral or
- 10 written, may include exculpatory language through which the
- 11 subject or representative waives or appears to waive a legal
- 12 right or releases or appears to release the investigator,
- 13 sponsor, institution or an agent from liability for negligence.
- 14 Section 4. Penalty.
- 15 A violation of any provision of this act constitutes a felony
- 16 of the third degree.
- 17 Section 5. Effective date.
- 18 This act shall take effect in 60 days.
