## AN ACT

1 Providing for the English language as the official language of  
2 the Commonwealth.

3 The General Assembly of the Commonwealth of Pennsylvania  
4 hereby enacts as follows:

5 Section 1. Short title.

6 This act shall be known and may be cited as the Official  
7 Language Act.

8 Section 2. Legislative findings.

9 The General Assembly finds and declares as follows:

10 (1) The people of the United States have brought to this  
11 nation the cultural heritage of many nations.

12 (2) The people of the United States, despite their many  
13 differences, have lived together harmoniously and  
14 productively as citizens of one nation.

15 (3) The traditional and common language of the United

1 States and of this Commonwealth is English.

2 (4) A knowledge of the common language is essential to  
3 full exercise of constitutional freedoms, informed and  
4 knowledgeable empowerment as voters, citizen checks against  
5 government abuses and individual prosperity and independence.

6 (5) The English language has been our strongest bond to  
7 one another as fellow citizens and has contributed  
8 substantially to national unity and societal cohesiveness.

9 (6) English has been this nation's language by custom  
10 only and warrants special legal protection.

11 (7) Government has a fiduciary responsibility to the  
12 citizenry to ensure that it operates as efficiently as  
13 possible, and the growth of multiple language bureaucracies  
14 and printing represents an abrogation of this fiduciary  
15 responsibility.

16 (8) The Commonwealth and its municipalities and the  
17 Federal Government also have a responsibility to ensure that  
18 citizens have opportunities to learn English.

19 Section 3. Purpose.

20 (a) Unifying role.--It is the purpose of this act to  
21 preserve, protect and strengthen the unifying role of English as  
22 the official language of this Commonwealth.

23 (b) Rights preserved.--This act shall not be construed in  
24 any way to infringe on the rights of citizens, who have every  
25 right to choose their own primary language, in the use of  
26 language for private conduct, nor shall this act be used to  
27 dictate language policies for the operation and administration  
28 of organizations or businesses in the unregulated private  
29 sector.

30 Section 4. Definitions.

1 The following words and phrases when used in this act shall  
2 have the meanings given to them in this section unless the  
3 context clearly indicates otherwise:

4 "Official acts of government." Any of the following:

5 (1) Actions of the Commonwealth and of its political  
6 subdivisions that carry the full weight and authority of law.

7 (2) Official documents recorded and maintained by the  
8 Commonwealth and its political subdivisions for the public  
9 domain, including tax records, professional licenses, deeds,  
10 real estate records, publicly probated wills and other  
11 documents of the court systems and public proceedings of the  
12 governing bodies of the Commonwealth and its political  
13 subdivisions.

14 Section 5. Designation of language of official acts.

15 English is hereby recognized as the official language of the  
16 Commonwealth and shall also be designated as the language of  
17 official acts of government.

18 Section 6. Policies.

19 The Commonwealth and its political subdivisions shall make no  
20 policies expressing a preference for any language other than  
21 English or diminishing or ignoring the unifying role of English  
22 as designated in this act, subject to the limitations in section  
23 8.

24 Section 7. Enforcement.

25 Elected and appointed officers of the Commonwealth and its  
26 political subdivisions shall take all reasonable steps to ensure  
27 that the role of English as the official language is preserved  
28 and enhanced.

29 Section 8. Limitations.

30 The provisions of this act shall not apply to the following:

- 1           (1) When Federal law imposes contrary provisions.
- 2           (2) When the public safety, health or justice requires
- 3           the use of other languages.
- 4           (3) Instruction in foreign language courses.
- 5           (4) Instruction designed to aid students with limited
- 6           English proficiency in their transition and integration into
- 7           the education system.
- 8           (5) The promotion of international commerce or tourism.

9   Section 9. Appropriations.

10       The General Assembly and the governing bodies of political  
11       subdivisions shall make no appropriations to promote the use of  
12       or demonstrate a preference for any language other than the  
13       official language, subject to the limitations in section 8.

14   Section 20. Effective date.

15       This act shall take effect in 90 days.
