12	(a) General ruleWhenever authorized by ordinance of the
13	governing body or upon petition of the electors to the county
14	board of electors of the county wherein the municipality is
15	located, an election shall be held upon one of the following

- 19 § 2912. Election of members of commission.
- 20 (a) General rule. -- A governmental study commission of
- 21 [seven, nine or eleven] five, seven or nine members, as
- 22 designated in the question, shall be elected by the qualified
- 23 voters at the same election the question is submitted to the
- 24 electors.

- 26 Section 2. Section 2919 heading of Title 53 is amended and
- 27 the section is amended by adding a subsection to read:
- 28 § 2919. Compensation [and], personnel and expenses.

- 30 (c) Commission expenses. -- A governing body of a municipality

- 1 shall approve appropriations to the commission for the
- 2 <u>reasonable expenses of the commission following agreement</u>
- 3 between the commission and the governing body on a budget
- 4 amount. Reasonable expenses of the commission include, but are
- 5 <u>not limited to, the costs of preparing and mailing educational</u>
- 6 materials to the electors of the municipality. Educational
- 7 <u>materials shall include a summary of the commission's</u>
- 8 recommendations and may include a minority report of the
- 9 <u>commission or a summary of the minority report.</u>
- 10 Section 3. This act shall take effect in 60 days.
