## AN ACT

- 1 Amending Titles 18 (Crimes and Offenses) and 42 (Judiciary and
- Judicial Procedure) of the Pennsylvania Consolidated
- 3 Statutes, prohibiting the use of name, portrait or picture of
- 4 a soldier in certain cases.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- 6 hereby enacts as follows:
- 7 Section 1. Title 18 of the Pennsylvania Consolidated
- 8 Statutes is amended by adding a section to read:
- 9 § 6713. Unauthorized use of name, portrait or picture of
- 10 deceased soldier.
- 11 (a) Offense. -- A person who knowingly uses the name, portrait
- 12 or picture of a deceased soldier for the purpose of advertising
- 13 for the sale of any goods, wares or merchandise or for the
- 14 solicitation of patronage for any business without having

- 1 obtained prior consent to the use by the soldier or by the
- 2 <u>soldier's spouse, immediate family member, trustee if the</u>
- 3 soldier is a minor or legally designated representative, commits
- 4 <u>a misdemeanor of the first degree.</u>
- 5 (b) Exceptions. -- Subsection (a) does not apply to the
- 6 <u>following:</u>
- 7 (1) The use of a soldier's name, portrait or picture in
- 8 an attempt to portray, describe or impersonate that soldier
- 9 <u>in a live performance, a single and original work of fine</u>
- 10 art, a play, book, article, musical work or film or on radio,
- 11 <u>television or other audio or audiovisual work if the</u>
- 12 performance, musical work, play, book, article or film does
- 13 <u>not itself constitute a commercial advertisement for any</u>
- qoods, wares or merchandise.
- 15 (2) The use of a soldier's name, portrait or picture for
- 16 <u>noncommercial purposes, including any news, public affairs or</u>
- 17 <u>sports broadcast or account.</u>
- 18 (3) The use of a soldier's name in truthfully
- 19 identifying the soldier as the author of a particular work or
- 20 <u>program or as the performer in a particular performance.</u>
- 21 (4) Any promotional materials, advertisements or
- 22 commercial announcements for a use described in paragraph
- 23 (1), (2) or (3).
- 24 (5) The use of photographs, video recordings and images
- by a person, firm or corporation practicing the profession of
- 26 photography to exhibit, in or about the professional
- 27 photographer's place of business or portfolio, specimens of
- 28 <u>the professional photographer's work, unless the exhibition</u>
- in continued by the professional photographer after written
- 30 notice objecting to the exhibition by the portrayed soldier

- or a person who may enforce the soldier's rights and
- 2 remedies.
- 3 (6) A soldier's picture or portrait that is not facially
- 4 identifiable.
- 5 (7) A photograph of a monument or a memorial that is
- 6 placed on any goods, wares or merchandise.
- 7 (c) Definition.--For the purposes of this section, "soldier"
- 8 means any active duty member or former member of the Armed
- 9 Forces of the United States, including any member who was killed
- 10 <u>in the line of duty.</u>
- 11 Section 2. Title 42 is amended by adding a section to read:
- 12 § 8316.1. Unauthorized use of name, portrait or picture of
- 13 <u>soldier.</u>
- 14 (a) Right of soldier.--The right to control and to choose
- 15 whether and how to use a soldier's name, portrait or picture for
- 16 commercial purposes is recognized as each soldier's right of
- 17 publicity.
- 18 (b) Liability. -- A person is liable for using the name,
- 19 portrait or picture of any soldier without having obtained prior
- 20 consent to the use by the soldier or by the soldier's spouse,
- 21 immediate family member, trustee if the soldier is a minor or
- 22 legally designated representative, if the person uses the name,
- 23 portrait or picture for any of the following purposes:
- 24 (1) Advertising for the sale of any goods, wares or
- 25 <u>merchandise.</u>
- 26 (2) Soliciting patronage for any business.
- 27 (3) Receiving consideration for the sale of any goods,
- 28 <u>wares or merchandise.</u>
- 29 (c) Remedies.--A person who uses the name, portrait or
- 30 picture of a soldier for a prohibited purpose without prior

- 1 consent from the soldier or a person who may enforce the
- 2 soldier's rights and remedies is subject to the following:
- 3 (1) Injunctive relief to prevent or restrain the
- 4 unauthorized use.
- 5 (2) Compensatory and punitive or exemplary damages.
- 6 (3) Attorney fees and costs.
- 7 (d) Damages. -- In calculating damages, any profits from the
- 8 <u>unauthorized use that are attributable to that use shall be</u>
- 9 <u>taken into account.</u>
- 10 (e) Supplemental rights.--The rights and remedies provided
- 11 <u>in this section supplement any other rights and remedies</u>
- 12 provided by law, including the right of privacy.
- 13 (f) Limitation of action.--Any claim for relief that is
- 14 requested pursuant to this section shall be brought within five
- 15 years after the unauthorized publication.
- 16 (q) Rights of action. -- The right of publicity is a property
- 17 right that survives a soldier's death. On the soldier's death,
- 18 only the following individuals may enforce the soldier's rights
- 19 and remedies in the following order:
- 20 <u>(1) The soldier's legally designated representative.</u>
- 21 <u>(2) The soldier's spouse.</u>
- 22 (3) The soldier's parents.
- 23 (4) The soldier's children.
- 24 (5) The soldier's grandchildren.
- 25 (h) Exceptions.--This section does not apply to the
- 26 following:
- 27 (1) The use of a soldier's name, portrait or picture in
- 28 <u>an attempt to portray, describe or impersonate that soldier</u>
- in a live performance, a single and original work of fine
- 30 art, a play, book, article, musical work or film or on radio,

- 1 television or other audio or audiovisual work if the
- 2 performance, musical work, play, book, article or film does
- 3 <u>not itself constitute a commercial advertisement for any</u>
- 4 goods, wares or merchandise.

1 Section 3. This act shall take effect in 60 days.
