AN ACT

- Amending the act of June 21, 1939 (P.L.566, No.284), entitled "An act defining the liability of an employer to pay damages for occupational disease contracted by an employe arising out 3 of and in the course of employment; establishing an elective 5 schedule of compensation; providing procedure for the determination of liability and compensation thereunder; 6 7 imposing duties on the Department of Labor and Industry, the Workmen's Compensation Board, Workmen's Compensation 9 Referees, and deans of medical schools; creating a medical 10 board to determine controverted medical issues; establishing 11 an Occupational Disease Fund in custody of the State 12 Workmen's Insurance Board; imposing upon the Commonwealth a part of the compensation payable for certain occupational 13 diseases; making an appropriation; and prescribing 14 15 penalties, " providing further benefits.
- 16 The General Assembly of the Commonwealth of Pennsylvania
- 17 hereby enacts as follows:
- 18 Section 1. Section 301 of the act of June 21, 1939 (P.L.566,
- 19 No.284), known as The Pennsylvania Occupational Disease Act, is
- 20 amended by adding a subsection to read:

- 1 Section 301. * * *
- 2 (m) Every person heretofore or hereafter qualified for
- 3 <u>additional compensation under the provisions of clause (2) of</u>
- 4 <u>subsection (a) or subsection (i) shall, beginning with the month</u>
- 5 following the effective date of this subsection, or the month of
- 6 qualification, whichever occurs later, be paid further
- 7 compensation of fifty dollars (\$50) per month during the period
- 8 of disability. Such further compensation paid to a person
- 9 <u>heretofore or hereafter qualified shall be paid by the</u>
- 10 <u>Commonwealth</u>.
- 11 Section 2. This act shall take effect July 1, 2008 2009, or <---
- 12 immediately, whichever is later.
