A RESOLUTION

1 2	Recognizing the economic and public safety virtues of expungement of specific criminal convictions.
3	WHEREAS, Many individuals who have made bad decisions in
4	their pasts and who have paid their debts to society are still
5	not given a fair chance with their futures; and
6	WHEREAS, Legislation is necessary to allow for expungement of
7	specific criminal convictions after a certain period of time;
8	and
9	WHEREAS, Without the possibility of expungement, individuals
10	with criminal histories are doomed to a life of menial
11	employment, government dependency or recidivism; and
12	WHEREAS, Expungement as a legal remedy offers hope to those
13	without access to decent employment; and
14	WHEREAS, This hope gives incentive for rehabilitation and for
15	becoming a productive member of society making positive economic
16	and social contributions; and
17	WHEREAS, Residents of this Commonwealth are burdened with

1 supporting individuals with criminal records through

2 unemployment benefits; and

3 WHEREAS, Expungement will alleviate this unfair burden and 4 eliminate certain individuals' dependency on government 5 benefits; and

6 WHEREAS, Failure to use expungement as a tool to enhance 7 economic efficiency makes a segment of our population

8 unemployable; and

9 WHEREAS, The Commonwealth subsidizes this same segment in the 10 welfare and prison systems; and

11 WHEREAS, The average cost of incarcerating a prisoner is

12 \$22,650 per year; and

13 WHEREAS, Significant portions of State budgets are now14 invested in the criminal justice system; and

15 WHEREAS, We have the opportunity to save money and cut down 16 on recidivism by allowing an individual to fully reintegrate 17 into society; and

18 WHEREAS, Many people have bettered their lives by attending 19 and graduating from colleges and universities throughout this 20 Commonwealth; and

21 WHEREAS, They have also acquired marketable skills only to 22 find out they cannot receive gainful employment because of their 23 criminal histories; and

24 WHEREAS, Expungement of specific criminal offenses will 25 reduce recidivism, thereby increasing overall public safety in 26 this Commonwealth; and

WHEREAS, Urban and rural areas of this Commonwealth can benefit from allowing people to clearly display a positive change in their lives and sufficiently provide for themselves and their families through expungement of specific criminal 20070H0255R1419 - 2 - 1 convictions; and

2 WHEREAS, Expungement will enable certain first-time offenders 3 to seek and find employment, and will reduce the amount of tax 4 dollars spent on welfare, thus creating a Pennsylvania which is 5 more desirable for its residents; and

6 WHEREAS, The Commonwealth pays a price when citizens cannot 7 find work and move forward with their lives; therefore be it 8 RESOLVED, That the House of Representatives recognize the 9 economic and public safety virtues of expungement of specific 10 criminal convictions.
