- 1 Recognizing the week of October 14 through 20, 2007, as "Credit Union Week" in Pennsylvania.
- 3 WHEREAS, Credit unions are individual, independent
- 4 cooperatives founded by people working together toward economic
- 5 advancement, uniting people seeking a way to improve their
- 6 future; and
- 7 WHEREAS, Credit unions call for the pooling of personal
- 8 resources and leadership abilities for the good of the
- 9 cooperative, provide low-cost financial services to their
- 10 members, encourage a regular habit of saving so those in need
- 11 may borrow and foster the desire to repay loans in order for
- 12 members to have access to credit when it is required; and

- 2 empowering people to improve their economic situations by
- 3 serving the financial needs of 3.37 million members associated
- 4 through State, local, regional and international organizations
