A RESOLUTION

- Recognizing March 30, 2008, as "Welcome Home Vietnam Veterans
- 2 Day" in Pennsylvania.
- WHEREAS, The Vietnam Conflict was fought in Vietnam from 1961
- to 1975, and it involved North Vietnam and the Viet Cong in
- conflict with the United States and South Vietnam; and
- 6 WHEREAS, The United States became involved in the Vietnam
- Conflict because policymakers in the United States believed that

- 1 if South Vietnam fell to a communist government then communism
- 2 would spread throughout the rest of Southeast Asia; and
- 3 WHEREAS, Members of the United States Armed Forces began
- 4 serving in an advisory role to South Vietnam in 1961; and
- 5 WHEREAS, As a result of the Gulf of Tonkin incidents on
- 6 August 2 and 4, 1964, the Congress of the United States
- 7 overwhelmingly passed the Gulf of Tonkin Resolution (Public Law
- 8 88-408) on August 7, 1964, which effectively handed over war-
- 9 making powers to President Lyndon B. Johnson until such time as
- 10 peace and security had returned to Vietnam; and
- 11 WHEREAS, In 1965, United States Armed Forces ground combat
- 12 units arrived in Vietnam; and
- WHEREAS, By the end of 1965, there were 80,000 United States
- 14 troops in Vietnam and by 1969, a peak of approximately 543,000
- 15 troops was reached; and
- 16 WHEREAS, On January 27, 1973, the Paris Peace Accords were
- 17 signed, which required the release of all United States
- 18 prisoners of war held in North Vietnam and the withdrawal of all
- 19 United States Armed Forces from South Vietnam; and
- 20 WHEREAS, On March 30, 1973, the United States Armed Forces
- 21 completed the withdrawal of combat troops from Vietnam; and
- 22 WHEREAS, More than 58,000 members of the United States Armed
- 23 Forces lost their lives in Vietnam, and more than 300,000
- 24 members were wounded; and
- 25 WHEREAS, In 1982, the Vietnam Veterans Memorial was dedicated
- 26 in the District of Columbia to commemorate those members of the
- 27 United States Armed Forces who died or were declared missing in
- 28 action in Vietnam; and
- 29 WHEREAS, The Vietnam Conflict was an extremely divisive issue
- 30 among the people of the United States; and

- 1 WHEREAS, Members of the United States Armed Forces who served
- 2 bravely and faithfully for the United States during the Vietnam
- 3 Conflict were caught upon their return home in the crossfire of
- 4 public debate about the involvement of the United States in the
- 5 Vietnam Conflict; therefore be it
- 6 RESOLVED, That the House of Representatives recognize the
- 7 honor in the establishment of "Welcome Home Vietnam Veterans
- 8 Day" and how it would be an appropriate way to honor those
- 9 members of the United States Armed Forces who served in Vietnam
- 10 during the Vietnam Conflict; and be it further
- 11 RESOLVED, That the House of Representatives recognize and
- 12 proclaim March 30, 2008, as "Welcome Home Vietnam Veterans Day"
- 13 in Pennsylvania.
