10	WHEREAS, Pfc. Holland joined the Pennsylvania Army National
11	Guard in 2006 as a member of Company A, 228th Brigade Support

1 Battalion from Bethlehem; and

2 WHEREAS, After enlistment, Pfc. Holland was subsequently
3 promoted to the rank of Private First Class; and
4 WHEREAS, Pfc. Holland was deployed with Company A to serve in

5 Afghanistan; and

6 WHEREAS, While serving in Afghanistan to provide security for 7 the team that was helping rebuild the Afghan infrastructure, 8 Pfc. Holland made the ultimate sacrifice for his country when an 9 improvised explosive device destroyed the Humvee in which he was 10 riding near the town of Zormat in Gardez Province, Afghanistan; 11 and

12 WHEREAS, Pfc. Holland will be posthumously awarded a Purple 13 Heart and a Combat Action Badge for his heroic actions; and 14 WHEREAS, Pfc. Holland is survived by his parents, Kathy L. 15 Andreas and David G. Holland; therefore be it

16 RESOLVED, That the House of Representatives pay tribute and 17 honor to the memory of Private First Class Derek D.
