SENATOR GORDNER, LABOR AND INDUSTRY, AS AMENDED, JUNE 5, 2007

AN ACT

1 Amending the act of November 10, 1999 (P.L.491, No.45), entitled
2 "An act establishing a uniform construction code; imposing
3 powers and duties on municipalities and the Department of
4 Labor and Industry; providing for enforcement; imposing
5 penalties; and making repeals," further providing for
6 application and for exemptions.

7 The General Assembly of the Commonwealth of Pennsylvania
8 hereby enacts as follows:

9 Section 1. Section 104(b)(7) of the act of November 10, 1999
10 (P.L.491, No.45), known as the Pennsylvania Construction Code
11 Act, amended July 15, 2004 (P.L.748, No.92), is amended and the
12 subsection is amended by adding a paragraph to read:

13 Section 104. Application.

14 * * *

15 (b) Exclusions.--This act shall not apply to:

16 * * *

17 (7) any recreational cabin if:

18 (i) the cabin is equipped with at least one smoke
19 detector, one fire extinguisher and one carbon monoxide

1 detector in both the kitchen and sleeping quarters; [and]
2 (ii) the owner of the cabin files with the
3 municipality either:

4 (A) an affidavit on a form prescribed by the
5 department attesting to the fact that the cabin meets
6 the definition of a "recreational cabin" in section
7 103; or

8 (B) a valid proof of insurance for the
9 recreational cabin, written and issued by an insurer
10 authorized to do business in this Commonwealth,
11 stating that the structure meets the definition of a
12 "recreational cabin" as defined in section 103[.];

14 ~~(8) temporary structures that are erected for a period~~ <—
15 ~~of less than 180 days.~~ ERECTED FOR A PERIOD OF 30 DAYS OR <—
16 LESS FOR THE PURPOSES OF PARTICIPATION IN A FAIR, FLEA
17 MARKET, ARTS AND CRAFTS FESTIVAL OR OTHER PUBLIC CELEBRATION.

19 Section 2. Section 901 of the act is amended by adding a
20 subsection to read:

21 Section 901. Exemptions.

23 ~~(e) Pole barns at agricultural fairs.--This act shall not~~ <—
24 NEITHER THIS ACT NOR ANY ADOPTION OF THE INTERNATIONAL FIRE CODE <—
25 BY A COMMONWEALTH AGENCY, A POLITICAL SUBDIVISION OR A LOCAL
26 AGENCY SHALL apply to a pole barn that is constructed on
27 agricultural fairgrounds and used for agricultural purposes and
28 animal display.

29 Section 3. This act shall take effect ~~in 60 days~~ <—
