- 3 SECTION 2. SECTION 714 OF TITLE 65 IS AMENDED TO READ:
- 4 § 714. Penalty.
- 5 Any member of any agency who participates in a meeting with
- 6 the intent and purpose by that member of violating this chapter
- 7 commits a summary offense and shall, upon conviction, be
- 8 sentenced to pay a fine not exceeding [\$100] \$1,000 plus costs
- 9 of prosecution[.] for a first offense and a fine not exceeding
- 10 \$2,000 plus costs of prosecution for a second or subsequent
- 11 offense. An agency shall not make a payment on behalf of or
- 12 reimburse a member of an agency for a fine or cost resulting
- 13 <u>from the member's violation of this section.</u>
- 14 Section  $\frac{2}{3}$ . This act shall take effect in 60 days.
