(b) (1) Except as otherwise provided under paragraph (2),
the new judgeships added by the amendment of 42 Pa.C.S. §
911(a) shall be established on January 4, 2010, and shall be initially filled by election at the 2009 municipal election.

5 (2) The new judgeship for the thirty-ninth judicial 6 district of this Commonwealth added by the amendment of 42 7 Pa.C.S. § 911(a) shall be established on January 2, 2012, and 8 shall be initially filled by election at the 2011 municipal 9 election.

10 Section 3. This act shall take effect in 60 days.
