- 29 [SALE] TRANSACTION.
- 30 (B) PENALTY.--A PERSON WHO VIOLATES SUBSECTION (A) COMMITS A

- 1 SUMMARY OFFENSE AND SHALL, UPON CONVICTION, BE SENTENCED TO PAY
- 2 A FINE NOT LESS THAN \$50.
- 3 SECTION 21. ESCROW ACCOUNT.
- 4 EVERY AUCTIONEER AND REGISTRANT SHALL IMMEDIATELY DEPOSIT
- 5 MONEYS, RECEIVED FROM THE SALE OF PROPERTY, BELONGING TO OTHERS
- 6 IN A SEPARATE CUSTODIAL OR TRUST FUND ACCOUNT MAINTAINED BY THE

- 9 SECTION 29. PENALTIES.
- 10 (A) CRIMINAL PENALTIES. -- ANY [INDIVIDUAL, PARTNERSHIP,
- 11 ASSOCIATION OR CORPORATION] PERSON WHO ENGAGES IN OR CARRIES ON
- 12 THE PROFESSION OR ACTS IN THE CAPACITY OF AN AUCTIONEER,
- 13 APPRENTICE AUCTIONEER, AUCTION HOUSE [OR], AUCTION COMPANY OR
- 14 TRADING ASSISTANT IN THIS COMMONWEALTH WITHOUT A CURRENT LICENSE
- 15 OR REGISTRATION OR WHO EMPLOYS ANY PERSON WITHOUT A CURRENT
- 16 LICENSE AS AN APPRENTICE AUCTIONEER:
- 17 (1) FOR A FIRST OFFENSE, COMMITS A SUMMARY OFFENSE AND
- 18 SHALL, UPON CONVICTION, BE SENTENCED TO PAY A FINE NOT
- 19 EXCEEDING \$500 OR TO IMPRISONMENT NOT EXCEEDING THREE MONTHS,
- 20 OR BOTH.
- 21 (2) FOR A SECOND OR SUBSEQUENT OFFENSE, COMMITS A
- 22 MISDEMEANOR OF THE THIRD DEGREE AND SHALL, UPON CONVICTION,
- BE SENTENCED TO PAY A FINE OF NOT LESS THAN \$2,000 BUT NOT

- 13 SECTION 31. STATE BOARD OF AUCTIONEER EXAMINERS.
- 14 (A) REPRESENTATION. -- THE STATE BOARD OF AUCTIONEER EXAMINERS
- 15 SHALL CONSIST OF THE COMMISSIONER OF PROFESSIONAL AND
- 16 OCCUPATIONAL AFFAIRS, THE DIRECTOR OF THE BUREAU OF CONSUMER
- 17 PROTECTION IN THE OFFICE OF ATTORNEY GENERAL, OR HIS DESIGNEE,
- 18 TWO MEMBERS APPOINTED BY THE GOVERNOR WITH THE ADVICE AND
- 19 CONSENT OF THE SENATE, WHO SHALL BE PERSONS REPRESENTING THE
