AN ACT

Amending the act of June 14, 1961 (P.L.324, No.188), entitled "An act relating to the establishment, operation and 3 maintenance of the State Library and public libraries in the Commonwealth; amending, revising, consolidating and changing 5 the laws relating thereto; imposing duties upon public officers; providing for State and local cooperation and 6 7 assistance in the establishment and maintenance of libraries; prescribing penalties; and repealing existing laws," providing for State-aid for 2008-2009. 9 10 The General Assembly of the Commonwealth of Pennsylvania hereby enacts as follows: 11 12 Section 1. The act of June 14, 1961 (P.L.324, No.188), known 13 as The Library Code, is amended by adding a section to read: 14 Section 303.17. State-aid for 2008-2009.--(a) 15 Notwithstanding any other provision of law to the contrary, each 16 library shall be eliqible for State-aid for fiscal year 2008-2009 if the library: 17 (1) received State-aid for fiscal year 2007-2008 under 18 19 section 2316 of the act of March 10, 1949 (P.L.30, No.14), known

- 16 (c) After distribution of State-aid to libraries under this
- 17 section, any remaining unallocated funds may be distributed at
- 18 the discretion of the State Librarian.
- 19 Section 2. This act shall take effect July 1, 2008, or
- 20 immediately, whichever is later.
