AN ACT

- Amending the act of July 2, 1935 (P.L.589, No.210), entitled, as amended, "An act to safeguard human health and life by 3 providing for the issuance of permits to, and regulation of persons and entities selling milk and milk products; 5 conferring powers, and imposing duties on the Secretary of Agriculture; and otherwise providing for the administration of the act; and imposing penalties, "further providing for 7 8 definitions; providing for raw milk products; and abrogating inconsistent regulations. 10 The General Assembly of the Commonwealth of Pennsylvania 11 hereby enacts as follows:
- 12 Section 1. Section 1 of the act of July 2, 1935 (P.L.589,
- 13 No.210), referred to as the Milk Sanitation Law, amended October
- 14 13, 1959 (P.L.1301, No.435) and June 19, 1982 (P.L.558, No.163),
- 15 is amended to read:
- 16 Section 1. Be it enacted, &c., That for the purpose and
- within the meaning of this act, the following definitions shall
- 18 obtain:
- 19 "Milk" means milk, skimmed milk, cream, sour milk, sour
- 20 cream, buttermilk, and all other fluid derivatives of milk.
- 21 "Milk products" means ice cream, ice cream mix, custard ice

- 1 cream, french ice cream, frozen custard, and other similar
- 2 frozen products, and all dairy products used in the manufacture
- 3 thereof.
- 4 "Canned milk" means condensed, evaporated or concentrated
- 5 milk in hermetically sealed containers or for manufacturing
- 6 purposes.
- 7 "Certified Milk" means milk from dairy farms operated in
- 8 accordance with the "Methods and Standards for the Production
- 9 and Distribution of 'Certified Milk,' last adopted by the
- 10 American Association of Medical Milk Commissions Incorporated,"
- 11 and the production and handling of which shall be certified to
- 12 by a commission instituted in compliance therewith.
- "Secretary" means the Secretary of Agriculture of this
- 14 Commonwealth, or his authorized representative.
- 15 "Person" includes singular and plural, masculine and
- 16 feminine, and any individual, firm, copartnership, institution,
- 17 association, or corporation thereof.
- 18 "To Sell," "for sale" or "sold" and similar terms means the
- 19 selling, exchanging, delivering, or having in possession, care,
- 20 control, or custody with intent to sell, exchange, or deliver,
- 21 or to offer or to expose for sale.
- 22 "Dairy farm" is a place or premise where one or more cows are
- 23 kept, and a part of all the milk from which is sold or delivered
- 24 to any person.
- 25 "Milk plant" is any place or premise or establishment where
- 26 milk is collected, separated, processed, stored, bottled,
- 27 pasteurized, or prepared in any manner for sale as milk, milk
- 28 products or manufactured dairy products.
- 29 "Approved inspector" is one, who has proven to the
- 30 satisfaction of the secretary, to be a person of good character,

- 1 trained by school and experience to carry on dairy farm and milk
- 2 plant inspection in a capable and efficient manner, and has
- 3 received a certificate of approval from the secretary.
- 4 Applications for certificates of approval for approved
- 5 inspectors shall be made on forms which may be secured from the
- 6 Secretary of Agriculture, and shall be accompanied by a fee of
- 7 fifteen (\$15) dollars. Certificates of approval shall expire on
- 8 December thirty-first of each year. Applications for renewal
- 9 shall be made on forms satisfactory to the Secretary of
- 10 Agriculture, and shall be accompanied by a registration fee of
- 11 five (\$5) dollars, and shall be returned to the Secretary of
- 12 Agriculture not later than December fifteenth of each year.
- 13 Certificates of approval shall not constitute an approved
- 14 inspector an official employe, agent or authorized
- 15 representative of the Department of Agriculture, nor shall he
- 16 represent himself so to be.
- 17 Certificates of approval may be refused, suspended or revoked
- 18 for cause, upon such notice and subject to such conditions, as
- 19 the secretary shall deem necessary.
- 20 "Municipality" includes any city, borough, town, or township
- 21 in this Commonwealth.
- 22 "Milk for manufacturing purposes" means milk produced for
- 23 processing and manufacturing into products for human consumption
- 24 but not subject to requirements of milk for pasteurization.
- 25 "Manufactured dairy products" means butter, cheese (natural
- 26 or processed), dry whole milk, nonfat dry milk, dry buttermilk,
- 27 dry whey, evaporated milk (whole or skim), condensed whole and
- 28 condensed skim milk (plain or sweetened), and such other
- 29 products for human consumption, as may be designated by the
- 30 secretary.

- 1 "Bed and breakfast homestead or inn" means a private
- 2 residence which contains no more than ten bedrooms used for
- 3 providing overnight accommodations to the public and in which
- 4 breakfast is the only meal served and is included in the charge
- 5 for the room.
- 6 <u>"Farmers' market" means a building, structure or place owned,</u>
- 7 <u>leased or otherwise in possession of a person, municipal</u>
- 8 corporation or public or private organization, used or intended
- 9 to be used by two or more farmers or an association of farmers
- 10 for the purpose of selling agricultural commodities directly to
- 11 consumers and which is located within this Commonwealth.
- 12 "Manufactured raw milk products" means butter, natural or
- 13 processed cheese, dry whole milk, nonfat dry milk, dry
- 14 buttermilk, dry whey, evaporated milk, whole or skim, condensed
- 15 whole and condensed skim milk, plain or sweetened, and such
- 16 other products for human consumption, as may be designated by
- 17 the secretary, manufactured from raw milk.
- 18 "Retail food establishment" means an establishment which
- 19 stores, prepares, packages, vends, offers for sale or otherwise
- 20 provides food for human consumption and which relinquishes
- 21 possession of food to a consumer directly, or indirectly,
- 22 through a delivery service such as home delivery of grocery
- 23 orders or delivery service provided by common carriers. The term
- 24 does not include dining cars operated by a railroad company in
- 25 <u>interstate commerce or a bed and breakfast homestead or inn.</u>
- 26 Section 2. The act is amended by adding a section to read:
- 27 Section 2.1. The secretary shall issue permits for the sale
- 28 of raw milk, "raw milk products" and "manufactured raw milk
- 29 products" by members of entities, including cooperatives,
- 30 incorporated groups or other associations, if all of the

- 1 following apply:
- 2 (a) The entity is registered with the Department of
- 3 Agriculture as required by the department.
- 4 (b) The entity inspects and issues permits to its members in
- 5 accordance with this act.
- 6 (c) The entity provides to the secretary, in the manner
- 7 required by the secretary, independent third-party verification
- 8 that all persons permitted under this section are in compliance
- 9 with standards established under this act.
- 10 (d) Raw milk products and manufactured raw milk products
- 11 produced under this section may:
- 12 (1) Be sold only under the direct supervision of a person
- 13 <u>holding a valid raw milk permit.</u>
- 14 (2) Not be sold to any person for the purposes of resale to
- 15 another person except for sale to a public eating establishment
- 16 or a bed and breakfast homestead or inn for on-site consumption
- 17 by patrons of the establishment.
- 18 (3) Not be repackaged in any manner for the purposes of
- 19 resale.
- 20 (d.1) The limitations under the sale of "manufactured raw
- 21 milk products" shall not apply to cheese manufactured from raw
- 22 milk that has been aged a minimum of sixty (60) days.
- 23 Section 3. The Department of Agriculture shall promulgate
- 24 regulations necessary to carry out the provisions of this act.
- 25 Section 4. All regulations inconsistent with the provisions
- 26 of this act are abrogated to the extent of the inconsistency.
- 27 Section 5. This act shall take effect in 60 days.
