Sexual abuse of children. 11 DEFINITION. -- AS USED IN THIS SECTION, "PROHIBITED 12 [(A) 13 SEXUAL ACT" MEANS SEXUAL INTERCOURSE AS DEFINED IN SECTION 3101 (RELATING TO DEFINITIONS), MASTURBATION, SADISM, MASOCHISM, 14 15 BESTIALITY, FELLATIO, CUNNILINGUS, LEWD EXHIBITION OF THE

- 1 GENITALS OR NUDITY IF SUCH NUDITY IS DEPICTED FOR THE PURPOSE OF
- 2 SEXUAL STIMULATION OR GRATIFICATION OF ANY PERSON WHO MIGHT VIEW

- 5 (d) [Possession of child] Child pornography.--
- 6 (1) Any person who <u>intentionally views or</u> knowingly
- 7 possesses or controls any book, magazine, pamphlet, slide,
- 8 photograph, film, videotape, computer depiction or other
- 9 material depicting a child under the age of 18 years engaging
- in a prohibited sexual act or in the simulation of such act
- 11 commits an offense.

- 13 (f) Exceptions. -- This section does not apply to any material
- 14 that is <u>viewed</u>, possessed, controlled, brought or caused to be
- 15 brought into this Commonwealth, or presented for a bona fide
- 16 educational, scientific, governmental or judicial purpose.
- 17 (G) DEFINITIONS.--AS USED IN THIS SECTION, THE FOLLOWING
- 18 WORDS AND PHRASES SHALL HAVE THE MEANINGS GIVEN TO THEM IN THIS
- 19 SUBSECTION:
- 20 "INTENTIONALLY VIEWS." THE DELIBERATE, PURPOSEFUL, VOLUNTARY
- 21 VIEWING OF MATERIAL DEPICTING A CHILD UNDER 18 YEARS OF AGE
- 22 ENGAGING IN A PROHIBITED SEXUAL ACT OR IN THE SIMULATION OF SUCH
- 23 ACT. THE TERM SHALL NOT INCLUDE THE ACCIDENTAL OR INADVERTENT
- 24 VIEWING OF SUCH MATERIAL.
- 25 "PROHIBITED SEXUAL ACT." SEXUAL INTERCOURSE AS DEFINED IN
- 26 SECTION 3101 (RELATING TO DEFINITIONS), MASTURBATION, SADISM,
- 27 MASOCHISM, BESTIALITY, FELLATIO, CUNNILINGUS, LEWD EXHIBITION OF
- 28 THE GENITALS OR NUDITY IF SUCH NUDITY IS DEPICTED FOR THE
- 29 PURPOSE OF SEXUAL STIMULATION OR GRATIFICATION OF ANY PERSON WHO
- 30 MIGHT VIEW SUCH DEPICTION.

1 Section 2. This act shall take effect in 60 days.
