AN ACT

- Amending the act of June 24, 1931 (P.L.1206, No.331), entitled
- "An act concerning townships of the first class; amending, 2
- revising, consolidating, and changing the law relating thereto," further providing for suits and property.
- 5 The General Assembly of the Commonwealth of Pennsylvania
- hereby enacts as follows:
- Section 1. Section 1501 of the act of June 24, 1931 (P.L. 7
- 8 1206, No.331), known as The First Class Township Code, reenacted
- and amended May 27, 1949 (P.L.1955, No.569) and amended December
- 10 19, 1997 (P.L.618, No.64), is amended to read:
- 11 Section 1501. Suits; Property. -- Townships of the first class
- 12 may--
- 13 I. Sue and be sued.
- 14 Purchase, acquire by gift, or otherwise, hold, lease,
- 15 let and convey, by sale or lease, such real and personal
- 16 property as shall be deemed to be to the best interest of the
- township: Provided, That no real estate owned by the township 17

- 1 shall be sold for a consideration in excess of one thousand five
- 2 hundred dollars except to the highest bidder after due notice by
- 3 advertisement for bids or advertisement of a public auction in
- 4 one newspaper of general circulation in the township. Such
- 5 advertisement shall be published once not less than ten days
- 6 prior to the date fixed for the opening of bids or public
- 7 auction, and such date for opening bids or public auction shall
- 8 be announced in such advertisement. The award of contracts shall
- 9 be made only by public announcement at a regular or special
- 10 meeting of the board of township commissioners or at the public
- 11 auction. All bids shall be accepted on the condition that
- 12 payment of the purchase price in full shall be made within sixty
- 13 days of the acceptance of bids.
- 14 The board of township commissioners shall have the authority
- 15 to reject all bids if such bids are deemed to be less than the
- 16 fair market value of the real property. In the case of a public
- 17 auction, the board of township commissioners may establish a
- 18 minimum bid based on the fair market value of the real property.
- 19 Except as otherwise hereinafter provided in the case of
- 20 personal property of an estimated fair market value of less than
- 21 one thousand dollars, no township personal property shall be
- 22 disposed of, by sale or otherwise, except upon approval of the
- 23 board of township commissioners, by ordinance or resolution. In
- 24 cases where the board of township commissioners shall approve a
- 25 sale of such property, it shall estimate the fair market value
- 26 of the entire lot to be disposed of. If the board of township
- 27 commissioners shall estimate the fair market value to be one
- 28 thousand dollars or more, the entire lot shall be advertised for
- 29 sale once, in at least one newspaper of general circulation in
- 30 the township, not less than ten days prior to the date fixed for

- 1 the opening of bids or public auction, and such date of opening
- 2 of bids or public auction shall be announced in such
- 3 advertisement, and sale of the property so advertised shall be
- 4 made to the best responsible bidder. A public auction of
- 5 personal property may be conducted by means of an online or
- 6 <u>electronic auction sale. During an electronic auction sale, bids</u>
- 7 <u>shall be accepted electronically at the time and in the manner</u>
- 8 <u>designated in the advertisement. During the electronic auction,</u>
- 9 <u>each bidder shall have the capability to view the bidder's bid</u>
- 10 rank or the high bid price. Bidders may increase their bid
- 11 prices during the electronic auction. The record of the
- 12 <u>electronic auction shall be accessible for public inspection.</u>
- 13 The purchase price shall be paid by the high bidder immediately
- 14 or at a reasonable time after the conclusion of the electronic
- 15 auction as determined by the board of township commissioners. In
- 16 the event that shipping costs are incurred, they shall be paid
- 17 by the high bidder. A township that has complied with the
- 18 advertising requirements of this clause may provide additional
- 19 public notice of the sale by bids or public auction in any
- 20 manner deemed appropriate by the board of township
- 21 commissioners. The advertisement for electronic auction sales
- 22 authorized in this clause shall include the Internet address or
- 23 means of accessing the electronic auction and the date, time and
- 24 <u>duration of the electronic auction</u>. The board of township
- 25 commissioners may reject any bids received if the bids are
- 26 believed to be less than the fair market value of the property.
- 27 The board of township commissioners shall, by resolution, adopt
- 28 a procedure for the sale of surplus personal property, either
- 29 individual items or lots of items, of an estimated fair market
- 30 value of less than one thousand dollars and the approval of the

- 1 board of township commissioners shall not be required for any
- 2 individual sale that shall be made in conformity to such
- 3 procedure.
- 4 The provisions of this clause shall not be mandatory where
- 5 township property is to be traded in or exchanged for new
- 6 township property.
- 7 The provisions of this clause shall not prohibit the sale or
- 8 exchange of township property to public utilities.
- 9 The provisions of this clause requiring advertising for bids
- 10 or sale at public auction and sale to the highest bidder shall
- 11 not apply where township real or personal property is to be sold
- 12 to a county, city, borough, town, township, institution
- 13 district, school district, volunteer fire company, volunteer
- 14 ambulance service or volunteer rescue squad located within the
- 15 township, or [municipal authority pursuant to the Municipality
- 16 Authorities Act of 1945] authority as defined in 53 Pa.C.S. §
- 17 <u>5602 (relating to definitions)</u>, or to a nonprofit corporation
- 18 engaged in community industrial, commercial or affordable
- 19 housing development or reuse or where real property is to be
- 20 sold to a person for his exclusive use in an industrial
- 21 development program or where real property is to be sold to a
- 22 nonprofit corporation organized as a public library, or where
- 23 real property is to be sold to a nonprofit medical service
- 24 corporation as authorized by clause LXXII of section 1502, or
- 25 where real property is to be sold to a nonprofit housing
- 26 corporation as authorized by clause LXXIII of section 1502. When
- 27 real property is to be sold to a nonprofit corporation organized
- 28 as a public library or to a nonprofit medical service
- 29 corporation or to a nonprofit housing corporation the board of
- 30 township commissioners may elect to accept such nominal

- 1 consideration for such sale as it shall deem appropriate. Real
- 2 property sold pursuant to this clause to a volunteer fire
- 3 company, volunteer ambulance service or volunteer rescue squad,
- 4 nonprofit medical service corporation or to a nonprofit housing
- 5 corporation shall be subject to the condition that when the
- 6 property is not used for the purposes of the company, service,
- 7 squad or the corporation the property shall revert to the
- 8 township.
- 9 Any officer who sells and each officer who votes in favor of
- 10 selling any township property, either real or personal, without
- 11 the provisions of this section having been complied with, shall
- 12 be subject to surcharge in the amount of any loss sustained by
- 13 the township by reason of such sale.
- 14 The exemption granted by this clause to nonprofit
- 15 corporations engaged in community, industrial, commercial or
- 16 affordable housing development or reuse shall not apply to
- 17 property owned and operated by the township or subcontracted or
- 18 operated on the behalf of the township in order to conduct
- 19 existing governmental functions.
- 20 Section 2. This act shall take effect immediately.
