AN ACT

1 Designating the bridge on U.S. Route 6 over Potato Creek at  
2 Smethport, McKean County, as the POW/MIA Memorial Bridge;  
3 designating State Route 120 in the Borough of Emporium as  
4 General Joseph T. McNarney Boulevard; and designating U.S.  
5 Route 6 over Allegheny River at Liberty Township, McKean  
6 County, as the Lt. Colonel Richard J. Berrettini Memorial  
7 Bridge.

8 The General Assembly of the Commonwealth of Pennsylvania  
9 hereby enacts as follows:

10 Section 1. POW/MIA Memorial Bridge.

11 (a) Designation.--The bridge on U.S. Route 6 over Potato  
12 Creek in the Borough of Smethport, McKean County, beginning at  
13 Segment 0780, offset 0000, is hereby designated as the POW/MIA  
14 Memorial Bridge.

15 (b) Signs.--The Department of Transportation shall erect and  
16 maintain appropriate signs at each end of the bridge displaying  
17 the name of the bridge.

1 Section 2. General Joseph T. McNarney Boulevard.

2 (a) Designation.--The section of State Route 120 through the  
3 Borough of Emporium, Cameron County, beginning at State Route  
4 120, Segment 0220, offset 08882 to State Route 120, Segment  
5 0260, offset 0585 for a total length of 7,375 feet or 1.4 miles  
6 is hereby designated as the General Joseph T. McNarney  
7 Boulevard.

8 (b) Signs.--The Department of Transportation shall erect and  
9 maintain appropriate signs to indicate the designation under  
10 subsection (a).

11 Section 3. Lt. Colonel Richard J. Berrettini Memorial Bridge.

12 (a) Designation.--The bridge on U.S. Route 6 over Allegheny  
13 River in Liberty Township, McKean County, is hereby designated  
14 as the Lt. Colonel Richard J. Berrettini Memorial Bridge.

15 (b) Signs.--The Department of Transportation shall erect and  
16 maintain appropriate signs to indicate the designation under  
17 subsection (a).

18 Section 4. Effective date.

19 This act shall take effect in 60 days.
