AN ACT

1 Designating the bridge on U.S. Route 6 over Potato Creek at
2 Smethport, McKean County, as the POW/MIA Memorial Bridge;
3 designating State Route 120 in the Borough of Emporium as
4 General Joseph T. McNarney MEMORIAL Boulevard; and
5 designating U.S. Route 6 over Allegheny River at Liberty
6 Township, McKean County, as the Lt. Colonel Richard J.
7 Berrettini Memorial Bridge.

8 The General Assembly of the Commonwealth of Pennsylvania
9 hereby enacts as follows:

10 Section 1. POW/MIA Memorial Bridge.

11 (a) Designation.--The bridge on U.S. Route 6 over Potato
12 Creek in the Borough of Smethport, McKean County, beginning at
13 Segment 0780, offset 0000, is hereby designated as the POW/MIA
14 Memorial Bridge.

15 (b) Signs.--The Department of Transportation shall erect and
16 maintain appropriate signs at each end of the bridge displaying

1 the name of the bridge.

2 Section 2. General Joseph T. McNarney MEMORIAL Boulevard. ←

3 (a) Designation.--The section of State Route 120 through the
4 Borough of Emporium, Cameron County, beginning at State Route
5 120, Segment 0220, offset 08882 to State Route 120, Segment
6 0260, offset 0585 for a total length of 7,375 feet or 1.4 miles
7 is hereby designated as the General Joseph T. McNarney MEMORIAL ←
8 Boulevard.

9 (b) Signs.--The Department of Transportation shall erect and
10 maintain appropriate signs to indicate the designation under
11 subsection (a) IN BOTH DIRECTIONS. ←

12 Section 3. Lt. Colonel Richard J. Berrettini Memorial Bridge.

13 (a) Designation.--The bridge on U.S. Route 6 over Allegheny
14 River in Liberty Township, McKean County, is hereby designated
15 as the Lt. Colonel Richard J. Berrettini Memorial Bridge.

16 (b) Signs.--The Department of Transportation shall erect and
17 maintain appropriate signs to indicate the designation under
18 subsection (a) IN BOTH DIRECTIONS. ←

19 Section 4. Effective date.

20 This act shall take effect in 60 days.
