- Amending the act of June 2, 1915 (P.L.736, No.338), entitled, as reenacted and amended, "An act defining the liability of an

- disease"; and providing for cancer in the occupation of 8

- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Section 108 of the act of June 2, 1915 (P.L.736,
- 13 No.338), known as the Workers' Compensation Act, reenacted and
- amended June 21, 1939 (P.L.520, No.281), is amended by adding a
- 15 clause to read:
- 16 Section 108. The term "occupational disease," as used in

- 1 this act, shall mean only the following diseases.
- 2 * * *
- 3 (r) Cancer, resulting in either temporary or permanent total
- 4 <u>or partial disability or death, after four years or more of</u>
- 5 <u>service in firefighting for the benefit or safety of the public,</u>
- 6 caused by exposure to heat, smoke, fumes or gasses, arising
- 7 directly out of the employment of any such firefighter.
- 8 Section 2. Section 301(c) of the act is amended by adding a
- 9 paragraph to read:
- 10 Section 301. * * *
- 11 (c) * * *
- 12 (3) The limitations of paragraph (2) shall not apply in the
- 13 case of cancer in the occupation of firefighter. The employer
- 14 shall have the burden of proving that the firefighter's
- 15 occupation was not a major contributing cause of the
- 16 firefighter's cancer.

- 18 Section 3. This act shall take effect immediately.
