AN ACT

- Amending the act of June 2, 1915 (P.L.736, No.338), entitled, as reenacted and amended, "An act defining the liability of an
- employer to pay damages for injuries received by an employe
- in the course of employment; establishing an elective
- schedule of compensation; providing procedure for the
- determination of liability and compensation thereunder; and
- 7 prescribing penalties," further defining "occupational"
- disease"; and providing for cancer in the occupation of firefighter.
- 10 The General Assembly of the Commonwealth of Pennsylvania
- 11 hereby enacts as follows:
- 12 Section 1. Section 108 of the act of June 2, 1915 (P.L.736,
- 13 No.338), known as the Workers' Compensation Act, reenacted and
- 14 amended June 21, 1939 (P.L.520, No.281), is amended by adding a
- 15 clause to read:

- 1 Section 108. The term "occupational disease," as used in
- 2 this act, shall mean only the following diseases.
- 3 * * *
- 4 <u>(r) Cancer, resulting in either temporary or permanent total</u>
- 5 <u>or partial disability or death, after four years or more of</u>
- 6 service in firefighting for the benefit or safety of the public,
- 7 <u>caused by exposure to heat, smoke, fumes or gasses CANCER</u>
- 8 AFFECTING THE SKIN OR THE CENTRAL NERVOUS, LYMPHATIC, DIGESTIVE,
- 9 <u>HEMATOLOGICAL</u>, <u>URINARY</u>, <u>SKELETAL</u>, <u>ORAL</u>, <u>BREAST</u>, <u>TESTICULAR</u>,
- 10 GENITOURINARY, LIVER OR PROSTATE SYSTEMS, AS WELL AS ANY
- 11 CONDITION OF CANCER THAT MAY RESULT FROM EXPOSURE TO HEAT OR
- 12 RADIATION OR TO A KNOWN OR SUSPECTED CARCINOGEN AS DETERMINED BY
- 13 THE INTERNATIONAL AGENCY FOR RESEARCH ON CANCER, arising
- 14 <u>directly out of the employment of any such firefighter.</u>
- 15 Section 2. Section 301(c) of the act is amended by adding a
- 16 paragraph to read:
- 17 Section 301. * * *
- 18 (c) * * *
- 19 (3) The limitations of paragraph (2) shall not apply in the
- 20 case of cancer in the occupation of firefighter. The employer
- 21 shall have the burden of proving that the firefighter's
- 22 occupation was not a major contributing cause of the
- 23 firefighter's cancer.

- 25 Section 3. This act shall take effect immediately.
