4	OVER THE CHEST CREEK, MAHAFFEY, CLEARFIELD COUNTY, AS THE
5	SERGEANT MAJOR MORTON SHEA LANDY MEMORIAL BRIDGE; DESIGNATING
6	THE DONORA-WEBSTER BRIDGE IN DONORA, WASHINGTON COUNTY, AS
7	THE LIEUTENANT GOVERNOR ERNEST P. KLINE MEMORIAL BRIDGE;
8	DESIGNATING A BRIDGE ON THAT PORTION OF S.R. 130 OVER THE
9	NORFOLK SOUTHERN RAIL LINES, TRAFFORD BOROUGH, ALLEGHENY AND
.0	WESTMORELAND COUNTIES, AS THE TRAFFORD VETERANS MEMORIAL
.1	BRIDGE; AND DESIGNATING THE INTERCHANGE OF BUSINESS ROUTE 60
2	WITH THORN RUN ROAD IN MOON TOWNSHIP, ALLEGHENY COUNTY, AS

- 15 hereby enacts as follows:
- 16 Section 1. The Purple Heart Interchange.
- 17 Declaration of policy. -- The General Assembly finds and
- declares as follows: 18
- 19 The Purple Heart is awarded, in the name of the
- President of the United States, to any member of the armed 20
- 21 forces who has been wounded or killed while serving, on or

- after April 5, 1917, with the United States Armed Forces.
- 2 (2) In 2005, The United States Department of Veterans
- 3 Affairs established the National Cemetery of the Alleghenies,
- 4 which is located in close proximity to Exit 48 (Southpointe)
- of Interstate 79 in Washington County.
- 6 (b) Designation.--Exit 48 (Southpointe) of Interstate 79 in
- 7 Washington County, in both directions, is hereby designated as
- 8 the Purple Heart Interchange.
- 9 (c) Signs.--The Department of Transportation shall, in
- 10 appropriate locations, erect and maintain signs displaying the
- 11 name designated under subsection (b).
- 12 SECTION 2. SERGEANT MAJOR MORTON SHEA LANDY MEMORIAL BRIDGE.
- 13 (A) FINDINGS AND DECLARATIONS. -- THE GENERAL ASSEMBLY FINDS
- 14 AND DECLARES AS FOLLOWS:
- 15 (1) MORTON SHEA LANDY OF MAHAFFEY ENTERED THE UNITED
- 16 STATES MARINE CORPS IN 1946.
- 17 (2) HE WAS A HIGHLY DECORATED VETERAN. WHEN HE RETIRED
- 18 AFTER SERVING 32 YEARS AND 30 DAYS HE HAD ATTAINED THE RANK
- 19 OF SERGEANT MAJOR AND WAS ONLY THE SECOND PERSON TO SERVE TWO
- 20 YEARS BEYOND THE 30-YEAR LIMIT.
- 21 (3) HE RECEIVED THE PURPLE HEART AND BRONZE STAR WITH
- 22 "V" FOR VALOR.
- 23 (B) DESIGNATION.--THE BRIDGE LOCATED ON S.R. 3001 IN
- 24 MAHAFFEY, CLEARFIELD COUNTY, OVER THE CHEST CREEK IS HEREBY
- 25 DESIGNATED THE SERGEANT MAJOR MORTON SHEA LANDY MEMORIAL BRIDGE.
- 26 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 27 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME DESIGNATED UNDER
- 28 SUBSECTION (A) TO TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
- 29 SECTION 3. LIEUTENANT GOVERNOR ERNEST P. KLINE MEMORIAL BRIDGE.
- 30 (A) FINDINGS AND DECLARATIONS.--THE GENERAL ASSEMBLY FINDS

- 1 AND DECLARES AS FOLLOWS:
- 2 (1) ERNIE KLINE WAS BORN ON JUNE 20, 1929, IN ALLENTOWN.
- 3 (2) ERNIE KLINE GRADUATED FROM ROSTRAVER HIGH SCHOOL IN
- 4 1947.
- 5 (3) AFTER GRADUATION, ERNIE KLINE SETTLED IN BEAVER
- 6 FALLS, BEAVER COUNTY, WHERE HE WON A SEAT ON THE BEAVER FALLS
- 7 CITY COUNCIL IN 1955.
- 8 (4) ERNIE KLINE WAS ELECTED IN 1964 TO REPRESENT BEAVER
- 9 AND LAWRENCE COUNTIES IN THE PENNSYLVANIA SENATE. HE SERVED
- 10 IN THIS POSITION FOR SIX YEARS. HE WAS ELECTED TO BE THE
- 11 SENATE MINORITY LEADER IN 1967.
- 12 (5) ERNIE KLINE WAS ELECTED THE 25TH LIEUTENANT GOVERNOR
- 13 OF PENNSYLVANIA UNDER MILTON SHAPP IN 1970. IN 1974, HE
- 14 BECAME THE FIRST LIEUTENANT GOVERNOR TO BE RE-ELECTED TO A
- 15 SECOND TERM. HE SERVED AS THE LIEUTENANT GOVERNOR UNTIL HIS
- 16 SECOND TERM EXPIRED IN 1979.
- 17 (6) UPON LEAVING PUBLIC OFFICE, ERNIE KLINE ESTABLISHED
- 18 A GOVERNMENT RELATIONS FIRM WHERE HE WORKED UNTIL HIS DEATH
- 19 ON MAY 13, 2009.
- 20 (B) DESIGNATION.--THE BRIDGE CARRYING ROUTE 1022 ACROSS THE
- 21 MONONGAHELA RIVER AND THE NORFOLK SOUTHERN AND CSX RAIL LINE
- 22 BETWEEN DONORA, WASHINGTON COUNTY, AND WEBSTER, WESTMORELAND
- 23 COUNTY, IS HEREBY DESIGNATED THE LIEUTENANT GOVERNOR ERNEST P.
- 24 KLINE MEMORIAL BRIDGE.
- 25 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 26 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
- 27 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
- 28 SECTION 4. TRAFFORD VETERANS MEMORIAL BRIDGE.
- 29 (A) DESIGNATION.--THE BRIDGE THAT CARRIES S.R. 130 IN
- 30 TRAFFORD BOROUGH, ALLEGHENY AND WESTMORELAND COUNTIES, OVER THE

- 1 NORFOLK SOUTHERN RAIL LINES IS HEREBY DESIGNATED THE TRAFFORD
- 2 VETERANS MEMORIAL BRIDGE.
- 3 (B) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 4 MAINTAIN APPROPRIATE SIGNS DISPLAYING THE NAME OF THE BRIDGE TO
- 5 TRAFFIC IN BOTH DIRECTIONS ON THE BRIDGE.
- 6 SECTION 5. ROBERT E. HARPER INTERCHANGE.
- 7 (A) DECLARATION OF POLICY. -- THE GENERAL ASSEMBLY FINDS AND
- 8 DECLARES AS FOLLOWS:
- 9 (1) ROBERT ERNEST HARPER WAS BORN AND RAISED IN
- 10 CORAOPOLIS, PENNSYLVANIA. HE GRADUATED FROM CORAOPOLIS HIGH
- 11 SCHOOL IN 1964 WHERE HE PLAYED BASEBALL, PLAYED TRUMPET IN
- 12 THE MARCHING BAND AND PUNTED FOR THE FOOTBALL TEAM.
- 13 (2) MR. HARPER GRADUATED FROM THE UNIVERSITY OF
- 14 PITTSBURGH IN 1968 WITH A DEGREE IN ECONOMICS.
- 15 (3) MR. HARPER SERVED HONORABLY AS A FIRST LIEUTENANT IN
- 16 VIETNAM AS A COMBAT RIFLE PLATOON LEADER. UPON LEAVING THE
- 17 ARMY, HE RETURNED HOME AND WAS CONFERRED A LAW DEGREE BY THE
- 18 UNIVERSITY OF PITTSBURGH IN 1974 AND BEGAN HIS LEGAL CAREER
- 19 WITH ALTER, WRIGHT AND BARON. HE THEN SERVED AS A MANAGING
- 20 PARTNER AT SPRINGER, BUSH AND PERRY BEFORE JOINING TUCKER
- 21 ARENSBERG TO MANAGE THE FIRM'S AIRPORT OFFICE. HE PRACTICED
- LAW FOR 36 YEARS.
- 23 (4) MR. HARPER SERVED AS MOON TOWNSHIP SUPERVISOR FROM
- 24 1980 TO 1983 AND WAS ACTIVE IN NUMEROUS CIVIC ORGANIZATIONS
- 25 WHERE HE SELFLESSLY WORKED TO IMPROVE THE COMMUNITY FOR
- 26 FUTURE GENERATIONS. HE WAS INSTRUMENTAL IN BRINGING
- 27 INFRASTRUCTURE IMPROVEMENTS TO THE TOWNSHIP AND WAS
- 28 RESPONSIBLE FOR BRINGING MONTOUR HEIGHTS COUNTRY CLUB TO ITS
- 29 CURRENT LOCATION ON CORAOPOLIS HEIGHTS ROAD.
- 30 (5) MR. HARPER WAS A LIFELONG MEMBER OF THE CORAOPOLIS

- 1 UNITED METHODIST CHURCH WHERE HE SERVED AS A CONGREGATIONAL
- 2 LAY LEADER, SINGER IN THE CHOIR AND ACTIVE PARTICIPANT IN THE
- 3 LIFE OF THE CHURCH. IN ADDITION, HE SERVED AS THE CHAIRMAN OF
- 4 THE UNITED METHODIST FOUNDATION OF WESTERN PENNSYLVANIA.
- 5 (6) MR. HARPER IS SURVIVED BY HIS LOVING WIFE OF 38
- 6 YEARS, BARBARA; THREE SONS, ROBERT EVAN (CAITLIN), REID
- 7 ANDREW AND JAMES RANDALL; AND A GRANDDAUGHTER, MARGARET RUTH.
- 8 HE ALSO LEAVES BEHIND A BROTHER, JACK, AND WAS PRECEDED IN
- 9 DEATH BY HIS PARENTS, HAROLD AND RUTH HARPER.
- 10 (B) DESIGNATION.--BUSINESS ROUTE 60 AT THORN RUN ROAD IN
- 11 MOON TOWNSHIP, ALLEGHENY COUNTY, IS HEREBY DESIGNATED AS THE
- 12 ROBERT E. HARPER INTERCHANGE.
- 13 (C) SIGNS.--THE DEPARTMENT OF TRANSPORTATION SHALL ERECT AND
- 14 MAINTAIN APPROPRIATE SIGNS TO INDICATE THE DESIGNATION UNDER
- 15 SUBSECTION (B).
- 16 Section $\frac{2}{6}$ 6. Effective date.
- 17 This act shall take effect in 60 days.
