AN ACT

- Amending Title 75 (Vehicles) of the Pennsylvania Consolidated Statutes, further providing for definitions.
- 3 The General Assembly of the Commonwealth of Pennsylvania
- 4 hereby enacts as follows:
- 5 Section 1. The definition of "emergency vehicle" in section
- 6 102 of Title 75 of the Pennsylvania Consolidated Statutes is
- 7 amended by adding a paragraph to read:
- 8 § 102. Definitions.
- 9 Subject to additional definitions contained in subsequent
- 10 provisions of this title which are applicable to specific
- 11 provisions of this title, the following words and phrases when
- 12 used in this title shall have, unless the context clearly
- 13 indicates otherwise, the meanings given to them in this section:
- 14 * * *
- 15 "Emergency vehicle." A fire department vehicle, police

- 1 vehicle, sheriff vehicle, ambulance, blood delivery vehicle,
- 2 human organ delivery vehicle, hazardous material response
- 3 vehicle, armed forces emergency vehicle, one vehicle operated by
- 4 a coroner or chief county medical examiner and one vehicle
- 5 operated by a chief deputy coroner or deputy chief county
- 6 medical examiner used for answering emergency calls, any vehicle
- 7 owned and operated by the Philadelphia Parking Authority
- 8 established in accordance with 53 Pa.C.S. Ch. 55 (relating to
- 9 parking authorities) and used in the enforcement of 53 Pa.C.S.
- 10 Ch. 57 (relating to taxicabs and limousines in first class
- 11 cities), or any other vehicle designated by the State Police
- 12 under section 6106 (relating to designation of emergency
- 13 vehicles by Pennsylvania State Police), or a privately owned
- 14 vehicle used in answering an emergency call when used by any of
- 15 the following:

- 17 (9) A coroner or county medical examiner and chief
- deputy coroner or chief deputy medical examiner.

- 20 Section 2. This act shall take effect in 60 days.
