## AN ACT

- 1 Establishing the Sales and Use Tax STUDY Commission; and
- 2 providing for study and report on sales and use tax.
- 3 WHEREAS, Since the enactment of this Commonwealth's first
- 4 sales and use tax, significant changes in the structure of the
- 5 State's economy have occurred; and
- 6 WHEREAS, These changes have had both salutary and detrimental
- 7 effects on business and consumers in this Commonwealth; and
- 8 WHEREAS, The sales and use tax has become checkered with more
- 9 than 50 exclusions and exemptions; and
- 10 WHEREAS, The addition of certain exclusions and exemptions
- 11 has caused confusion for consumers and vendors in the payment
- 12 and collection of the sales and use tax; and
- 13 WHEREAS, Many of the existing exclusions and exemptions have
- 14 become antiquated and obsolete; and
- 15 WHEREAS, Ensuring greater fairness in the sales and use tax
- 16 will create a fair and more competitive climate leading to

- 1 greater economic growth and stability in this Commonwealth; and
- 2 WHEREAS, Viable opportunities to broaden the sales and use
- 3 tax base should be comprehensively explored to enable this
- 4 Commonwealth to lower the overall tax burden on the citizens of
- 5 this State while also protecting the stability of the State
- 6 budget.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Short title.
- 10 This act shall be known and may be cited as the Sales and Use
- 11 Tax Study Act.
- 12 Section 2. Purpose.
- 13 The purpose of this act is to establish the Pennsylvania
- 14 Sales and Use Tax STUDY Commission to study and analyze the
- 15 existing sales and use tax law, and to propose recommendations
- 16 to the Governor and the General Assembly for amending the tax
- 17 to:
- 18 (1) eliminate obsolete and unnecessary provisions;
- 19 (2) expand the tax base as necessary;
- 20 (3) ensure a competitive economic market in this State;
- 21 and
- 22 (4) protect the stability of the Commonwealth's budget.
- 23 Section 3. Definitions.
- 24 The following words and phrases when used in this act shall
- 25 have the meanings given to them in this section unless the
- 26 context clearly indicates otherwise:
- 27 "Commission." The Sales and Use Tax Study Commission
- 28 established under this act.
- "Department." The Department of Revenue of the
- 30 Commonwealth.

- 1 Section 4. Pennsylvania Sales and Use Tax STUDY Commission.
- 2 (a) Establishment. -- There is hereby established the
- 3 Pennsylvania Sales and Use Tax STUDY Commission.
- 4 (b) Purpose. -- The purpose of the commission shall be to
- 5 evaluate the current sales and use tax structure in the
- 6 Commonwealth and recommend changes to the sales and use tax
- 7 structure that will eliminate obsolete provisions and broaden
- 8 the tax base, as necessary, thereby allowing the overall tax
- 9 burden to be reduced and creating a better tax climate in this
- 10 Commonwealth.
- 11 Section 5. Tasks.
- 12 (a) Study. -- The commission shall study viable options for
- 13 increasing fairness and competitiveness in the sales and use tax
- 14 structure of the Commonwealth. The commission shall develop
- 15 solutions to ensure that the portion of State general funds
- 16 derived from the sales and use tax is not diminished.
- 17 (b) Report.--The commission shall provide a comprehensive
- 18 report of the study conducted under subsection (a). The report
- 19 shall thoroughly discuss options and viable recommendations
- 20 considered and express clear rationales for options not
- 21 recommended. Specific changes to the sales and use tax
- 22 recommended by the commission shall be included in the report.
- 23 The commission shall present the report to the Governor, the
- 24 chairman and minority chairman of the Finance Committee of the
- 25 Senate and the chairman and minority chairman of the Finance
- 26 Committee of the House of Representatives on or before July 1,
- 27 2010.
- 28 Section 6. Composition of the commission.
- 29 (a) Members. -- The commission shall consist of the following
- 30 members:

- 1 (1) Seven members appointed by the Governor. The
- 2 appointees shall be members of various constituencies
- 3 affected by or knowledgeable about the sales and use tax and
- 4 its impact on this Commonwealth's economy. These
- 5 constituencies include, but are not limited to, corporations,
- 6 tax policy experts and tax practitioners. Four of the
- Governor's seven appointees, one from each organization,
- 8 shall be members of the Pennsylvania Bar Association, the
- 9 Pennsylvania Chamber of Business and Industry, the
- 10 Pennsylvania Institute of Certified Public Accountants and
- 11 the Pennsylvania Retailers Association.
- 12 (2) Each of the four caucuses of the General Assembly
- 13 shall THE PRESIDENT PRO TEMPORE OF THE SENATE AND THE
- 14 MINORITY LEADER OF THE SENATE AND THE SPEAKER OF THE HOUSE OF
- 15 REPRESENTATIVES AND THE MINORITY LEADER OF THE HOUSE OF
- 16 REPRESENTATIVES SHALL EACH select one private sector citizen
- 17 representative from constituencies affected by or
- 18 knowledgeable about the Commonwealth's business taxes.
- 19 Staff from organizations representing business organizations are
- 20 not eligible for membership on the commission.
- 21 (b) Chairperson. -- The Secretary of Revenue shall chair the
- 22 commission and shall serve as a member.
- 23 (c) Staffing.--The Commonwealth shall, through the
- 24 department, provide reasonable and necessary clerical, research
- 25 and administrative support and may contract for research,
- 26 analysis and editorial work in support of the commission as
- 27 necessary.
- 28 Section 7. Public meetings.
- 29 All meetings, except for organizational meetings and planning
- 30 sessions shall be conducted as open meetings under 65 Pa.C.S.

- 1 Ch. 7 (relating to open meetings).
- 2 Section 8. Cooperation by State agencies.
- 3 The department shall serve as the administrative support
- 4 agency of the commission and shall provide facilities, personnel
- 5 assistance, information and services necessary to fulfill the
- 6 mission of the commission. All other Commonwealth agencies are
- 7 directed to cooperate with and assist the commission in
- 8 fulfilling its duties and responsibilities.
- 9 Section 9. Expiration.
- 10 This act shall expire 180 days after the submission of the
- 11 report provided for under section 5.
- 12 Section 10. Effective date.
- 13 This act shall take effect immediately.
