## AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for definitions and for
- sentencing for homicide by vehicle; providing for the offense
- of aggravated assault by vehicle; and imposing penalties.
- 5 RESOLVED, That this act may be referred to as the Sqt.
- 6 Michael C. Weigand Law.
- 7 The General Assembly of the Commonwealth of Pennsylvania
- 8 hereby enacts as follows:
- 9 Section 1. Section 102 of Title 75 of the Pennsylvania
- 10 Consolidated Statutes is amended by adding definitions to read:
- 11 § 102. Definitions.
- 12 Subject to additional definitions contained in subsequent
- 13 provisions of this title which are applicable to specific
- 14 provisions of this title, the following words and phrases when
- 15 used in this title shall have, unless the context clearly
- 16 indicates otherwise, the meanings given to them in this section:

- 1 <u>"Emergency medical services personnel." Includes, but is not</u>
- 2 limited to, the following persons while working within the scope
- 3 of their employment:
- 4 <u>(1) Doctors.</u>
- 5 <u>(2) Residents.</u>
- 6 (3) Interns.
- 7 <u>(4) Registered nurses.</u>
- 8 <u>(5) Licensed practical nurses.</u>
- 9 <u>(6) Nurse aides.</u>
- 10 (7) Ambulance attendants and operators.
- 11 <u>(8) Paramedics.</u>
- 12 (9) Emergency medical technicians.
- 13 <u>(10) Members of a hospital security force.</u>
- 14 "Emergency service responder." An individual acting in an
- 15 official capacity as any of the following:
- 16 <u>(1) A police officer.</u>
- 17 (2) A sheriff or deputy sheriff.
- 18 (3) A coroner or deputy coroner.
- 19 (4) A firefighter.
- 20 <u>(5)</u> Fire police.
- 21 (6) A fire marshal.
- 22 (7) A medical examiner or deputy medical examiner.
- 23 (8) Rescue personnel.
- 24 (9) Ambulance personnel.
- 25 (10) Towing and recovery personnel.
- 26 (11) Highway maintenance and construction personnel.
- 27 (12) <u>Hazardous material response team member.</u>
- 28 (13) Emergency medical services personnel.

- 30 "Serious bodily injury." Any bodily injury which creates a

- 1 <u>substantial risk of death or which causes serious</u>, permanent
- 2 disfigurement or protracted loss or impairment of the function
- 3 of any bodily member or organ.
- 4 Section 2. Section 3732(b) of Title 75 is amended to read:
- 5 § 3732. Homicide by vehicle.

- 7 (b) Sentencing.--
- 8 (1) In addition to any other penalty provided by law, a
- 9 person convicted of a violation of subsection (a) may be
- sentenced to an additional term not to exceed five years'
- 11 confinement if at trial the prosecution proves beyond a
- 12 reasonable doubt that the offense occurred in an active work
- zone <u>or the victim was an emergency service responder</u> as
- defined in section 102 (relating to definitions).
- 15 (2) The prosecution must indicate intent to proceed
- under this section in the indictment or information which
- 17 commences the prosecution.
- 18 (3) The Pennsylvania Commission on Sentencing, pursuant
- to 42 Pa.C.S. § 2154 (relating to adoption of guidelines for
- sentencing), shall provide for a sentencing enhancement for
- 21 an offense under this section when the violation occurred in
- 22 an active work zone or the victim was an emergency service
- 23 <u>responder</u> as defined in section 102.
- 24 Section 3. Title 75 is amended by adding a section to read:
- 25 § 3732.1. Aggravated assault by vehicle.
- 26 (a) Offense. -- Any person who recklessly or with gross
- 27 <u>negligence causes serious bodily injury to another person while</u>
- 28 engaged in the violation of any law of this Commonwealth or
- 29 municipal ordinance applying to the operation or use of a
- 30 vehicle or to the regulation of traffic, except section 3802

- 1 (relating to driving under influence of alcohol or controlled
- 2 <u>substance</u>), is guilty of aggravated assault by vehicle, a felony
- 3 of the third degree when the violation is the cause of the
- 4 <u>injury.</u>
- 5 (b) Sentencing.--
- 6 (1) In addition to any other penalty provided by law, a
- 7 person convicted of a violation of subsection (a) may be
- 8 <u>sentenced to an additional term not to exceed two years'</u>
- 9 <u>confinement if at trial the prosecution proves beyond a</u>
- 10 reasonable doubt that the offense occurred in an active work
- zone or the victim was an emergency service responder.
- 12 (2) The prosecution must indicate intent to proceed
- 13 <u>under this section in the indictment or information which</u>
- commences the prosecution.
- 15 (3) The Pennsylvania Commission on Sentencing, under 42
- Pa.C.S. § 2154 (relating to adoption of guidelines for
- sentencing), shall provide for a sentencing enhancement for
- an offense under this section when the violation occurred in
- an active work zone or the victim was an emergency service
- 20 responder.
- 21 Section 4. This act shall take effect in 60 days.
