Authorizing THE DEPARTMENT OF GENERAL SERVICES, WITH THE APPROVAL OF THE GOVERNOR, TO GRANT AND CONVEY TO THE PENNSYLVANIA STATE UNIVERSITY, CERTAIN LANDS SITUATE IN BENNER TOWNSHIP, CENTRE COUNTY; AUTHORIZING THE DEPARTMENT OF GENERAL SERVICES, WITH THE APPROVAL OF THE GOVERNOR, TO GRANT AND CONVEY TO BENNER TOWNSHIP, CERTAIN LANDS SITUATE IN BENNER TOWNSHIP, CENTRE COUNTY; AUTHORIZING THE DEPARTMENT OF GENERAL SERVICES, WITH THE APPROVAL OF THE GOVERNOR, TO GRANT AND CONVEY TO THE PENNSYLVANIA FISH AND BOAT COMMISSION, 9 CERTAIN LANDS SITUATE IN BENNER TOWNSHIP, CENTRE COUNTY; 10 AUTHORIZING THE DEPARTMENT OF GENERAL SERVICES, WITH THE APPROVAL OF THE GOVERNOR, TO GRANT AND CONVEY TO THE 12 PENNSYLVANIA GAME COMMISSION, CERTAIN LANDS SITUATE IN BENNER 13 TOWNSHIP, CENTRE COUNTY; AUTHORIZING the Department of 14 Conservation and Natural Resources, with the approval of the 15 Governor, to grant and convey to the Canaan Bible Chapel certain lands situate in South Canaan Township, Wayne County, 17 in exchange for certain property in South Canaan Township, 18 Wayne County, to be conveyed by the Canaan Bible Chapel to 19 the Commonwealth of Pennsylvania; AUTHORIZING THE DEPARTMENT 20 OF GENERAL SERVICES, WITH THE APPROVAL OF THE DEPARTMENT OF 21 EDUCATION AND THE GOVERNOR, TO GRANT AND CONVEY TO MARYWOOD 22 UNIVERSITY APPROXIMATELY TEN ACRES INCLUDING NINE BUILDINGS 23 AND ALL IMPROVEMENTS THEREON, KNOWN AS THE SCRANTON STATE 24 25 SCHOOL FOR THE DEAF, SITUATE AT 1800 N. WASHINGTON AVENUE IN THE CITY OF SCRANTON AND BOROUGH OF DUNMORE, LACKAWANNA COUNTY; AUTHORIZING THE DEPARTMENT OF GENERAL SERVICES, WITH 27 THE APPROVAL OF THE GOVERNOR, TO GRANT AND CONVEY TO THE 28 PHILADELPHIA AUTHORITY FOR INDUSTRIAL DEVELOPMENT, CERTAIN 29 LANDS SITUATE IN THE 38TH WARD OF THE CITY OF PHILADELPHIA, 30 PHILADELPHIA COUNTY; AND AUTHORIZING THE DEPARTMENT OF 31 GENERAL SERVICES, WITH THE APPROVAL OF THE GOVERNOR AND THE 32 DEPARTMENT OF PUBLIC WELFARE, TO GRANT AND CONVEY TO 33 FRENCHCREEK TOWNSHIP, VENANGO COUNTY, APPROXIMATELY 1.15-

- 24 THE LAND CONVEYED HEREIN SHALL BE USED SOLELY FOR
- 25 AGRICULTURAL PURPOSES IN THE FURTHERANCE OF THE GRANTEE'S
- 26 MISSION OF EDUCATION RELATED TO AGRICULTURAL SCIENCES. SHOULD
- 27 THE GRANTEE ATTEMPT TO CONVEY THE PROPERTY, OR ANY PORTION
