AN ACT

- Amending the act of March 4, 1971 (P.L.6, No.2), entitled "An act relating to tax reform and State taxation by codifying and enumerating certain subjects of taxation and imposing 3 taxes thereon; providing procedures for the payment, 5 collection, administration and enforcement thereof; providing for tax credits in certain cases; conferring powers and imposing duties upon the Department of Revenue, certain employers, fiduciaries, individuals, persons, corporations 8 and other entities; prescribing crimes, offenses and 9 penalties," providing for an income tax checkoff to provide 10 funding for the Children's Trust Fund. 11 12 The General Assembly of the Commonwealth of Pennsylvania 1.3 hereby enacts as follows: 14 Section 1. The act of March 4, 1971 (P.L.6, No.2), known as the Tax Reform Code of 1971, is amended by adding a section to 16 read: 17 Section 315.10. Contributions for the Children's Trust

- 11 to the Children's Trust Fund.
- 12 Section 2. This act shall take effect in 60 days.
