Section 2164(6) of Title 53 of the Pennsylvania Consolidated Statutes is amended to read: § 2164. Powers and duties of commission. The powers and duties of the commission shall be as follows: 10 11 12 To require every police officer to [attend] 13 <u>successfully complete</u> a minimum number of [hours] <u>continuing</u> education units (CEU) of in-service training as provided for 14 15 by regulation, unless the officer's employer files a show 16 cause document with the commission requesting additional time 17 for the officer to comply with the in-service training
