A RESOLUTION

1 Honoring the life and extending condolences for the supreme
 2 sacrifice of Officer David Tome of the Northern York County
 3 Regional Police Department who was killed in the line of duty
 4 on Tuesday, October 21, 2008, when he was struck by a motor
 5 vehicle.

6 WHEREAS, Officer David Tome, age 31, Badge No. 34-119 had
 7 served on the Northern York County Regional Police Department
 8 (NYCRPD) for five years and six months; and

9 WHEREAS, Officer Tome was a 1996 graduate of Spring Grove
 10 Area High School; and

11 WHEREAS, Officer Tome attended Harrisburg Area Community
 12 College's Police Academy in 2002 and was hired by the Northern

1 York County Regional Police Department in 2003; and

2 WHEREAS, Officer Tome was a trained accident
3 reconstructionist for the NYCRPD; and

4 WHEREAS, On Tuesday, October 21, 2008, while assisting in the
5 reconstruction of a fatal accident scene on Route 15 near
6 Clearsprings Road, Franklin Township, York County, Officer Tome
7 made the ultimate sacrifice when he was struck and killed in the
8 line of duty; and

9 WHEREAS, Officer Tome is survived by a wife and two children;
10 therefore be it

11 RESOLVED, That the House of Representatives honor the life
12 and extend condolences for the supreme sacrifice of Officer
13 David Tome; and be it further

14 RESOLVED, That a copy of this resolution be transmitted to
15 Officer David Tome's widow and children.
