- January 30, Franklin Delano Roosevelt's birthday, as "Day of the 10
- 11 Disabled"; and
- 12 WHEREAS, The act of June 2, 1993 (P.L.44, No.14), amended the
- act of May 26, 1988 (P.L.413, No.71), to designate January 30,
- 14 Franklin Delano Roosevelt's birthday, as "Pennsylvanians with
- Disabilities Day"; and 15
- 16 WHEREAS, Pennsylvanians with Disabilities Day is meant,
- 17 according to the act of June 2, 1993 (P.L.44, No.14), to

- 1 recognize and honor "citizens of Pennsylvania who have
- 2 disabilities"; therefore be it
- 3 RESOLVED, That the House of Representatives urge the Governor
- 4 to issue a proclamation to observe January 30, 2010, as
- 5 "Pennsylvanians with Disabilities Day" in Pennsylvania; and be
