## A RESOLUTION

- Supporting the goals and ideals of "National Mentoring Month 2010" in Pennsylvania.
- 3 WHEREAS, Evidence-based mentoring is a longstanding concept
- 4 in which a dependable adult provides guidance, support and
- 5 encouragement to facilitate a young person's social, emotional
- 6 and cognitive development; and
- 7 WHEREAS, High-quality, evidence-based mentoring promotes
- 8 positive outcomes for young people, including an increased sense
- 9 of industry and competency, a boost in academic performance and
- 10 self-esteem and improved social and communications skills; and
- 11 WHEREAS, Research shows that participation in a high-quality,
- 12 evidence-based mentoring relationship successfully reduces the

- 1 incidence of violence, delinquency, substance abuse and academic
- 2 failure in young people; and
- 3 WHEREAS, Research also shows that participation in a high-
- 4 quality, evidence-based mentoring relationship dramatically
- 5 reduces dependence on social services and results in a cost
- 6 benefit to the Commonwealth; and
- 7 WHEREAS, Evidence-based mentoring, in addition to being
- 8 beneficial for those being mentored, is also extremely rewarding
- 9 for those serving as mentors; and
- 10 WHEREAS, Quality programs that encourage young people to
- 11 learn about evidence-based mentoring and to become mentors, such
- 12 as programs that recruit high school students to mentor younger
- 13 children, are important and have the potential to create high-
- 14 quality mentors at an early age; and
- WHEREAS, Evidence-based mentoring relationships have grown
- 16 dramatically in the past 15 years, now reaching three thousand
- 17 young Pennsylvanians, because of the remarkable creativity,
- 18 vigor and resourcefulness of evidence-based mentoring programs
- 19 and volunteer mentors in communities throughout this
- 20 Commonwealth; and
- 21 WHEREAS, In spite of the progress made to increase evidence-
- 22 based mentoring, this Commonwealth has a serious mentoring gap,
- 23 with thousands of young people currently in need of mentors; and
- 24 WHEREAS, A recent study confirmed that one of the most
- 25 critical challenges that evidence-based mentoring programs face
- 26 is recruiting enough mentors to help close the mentoring gap;
- 27 and
- 28 WHEREAS, The month-long celebration of evidence-based
- 29 mentoring will encourage more individuals and organizations,
- 30 including schools, businesses, nonprofit organizations, faith

- 1 institutions and foundations, to become engaged in evidence-
- 2 based mentoring across this Commonwealth; and
- 3 WHEREAS, "National Mentoring Month 2010" will build awareness
- 4 of evidence-based mentoring and recruit more individuals to
- 5 become mentors, thus helping close this nation's mentoring gap;
- 6 therefore be it
- 7 RESOLVED, That the House of Representatives support the goals
- 8 and ideals of "National Mentoring Month 2010"; and be if further
- 9 RESOLVED, That the House of Representatives acknowledge the
- 10 diligent efforts of individuals and groups who promote evidence-
- 11 based mentoring and who are observing "National Mentoring Month
- 12 2010" with appropriate ceremonies and activities to further
- 13 promote awareness of and volunteer involvement with youth
- 14 mentoring; and be if further
- 15 RESOLVED, That the House of Representatives recognize with
- 16 gratitude the contributions of the millions of caring adults and
- 17 students who are already volunteering as mentors and encourage
- 18 more adults and students to volunteer as mentors.
