A RESOLUTION

- 1 Adopting the Pennsylvania History Bill of Rights.
- WHEREAS, Understanding Pennsylvania's history is key to
- 3 understanding America's history; and
- 4 WHEREAS, Section 27 of Article I of the Constitution of
- 5 Pennsylvania makes the Commonwealth trustee for the preservation
- 6 of the historic values of the environment; and
- 7 WHEREAS, The irreplaceable historical, architectural,
- 8 archaeological and cultural heritage of this Commonwealth should
- 9 be preserved and protected for the benefit of all people,
- 10 including future generations; and
- 11 WHEREAS, The preservation and protection of historic
- 12 resources in this Commonwealth promote public health, prosperity
- 13 and general welfare; and
- 14 WHEREAS, It is in the public interest for the Commonwealth,

- 1 its citizens and its political subdivisions to engage in
- 2 comprehensive programs of historic preservation for the
- 3 enjoyment, education and inspiration of all people, including
- 4 future generations; and
- 5 WHEREAS, Many individuals and organizations across this
- 6 Commonwealth are working diligently to make sure that history is
- 7 not lost; therefore be it
- 8 RESOLVED, That the House of Representatives join with other
- 9 heritage and cultural organizations across this Commonwealth to
- 10 adopt the following Pennsylvania History Bill of Rights and its
- 11 guiding principles that reflect the needs and expectations of
- 12 Pennsylvania's citizens in preserving Pennsylvania's heritage:
- 13 Students in Pennsylvania schools understand
- 14 Pennsylvania's history in the context of world, national and
- 15 local events.
- Pennsylvania maintains a competitive position as a
- 17 premier tourism destination for heritage travelers.
- 18 Pennsylvania citizens have access to the current records
- of government and the permanently valuable documents which
- tell the history of this Commonwealth.
- 21 Current and future generations are assured that
- Pennsylvania's historical resources are preserved for their
- enjoyment and use.
- Pennsylvania's museums, historical societies and historic
- 25 sites receive adequate public and private support to maintain
- high standards of stewardship and public access.
- 27 Pennsylvania's communities retain the historic character
- and distinctiveness that are essential to attracting and
- retaining residents, businesses and visitors.
