INTRODUCED AS NONCONTROVERSIAL RESOLUTION UNDER RULE 35, SEPTEMBER 28, 2010

A RESOLUTION

- 1 Designating the month of October 2010 as "Pennsylvania Fire
- 2 Prevention Month," observing the week of October 3 through 9,
- 2010, as "National Fire Prevention Week" and urging
- 4 Pennsylvanians to follow all safety measures to prevent
- fires, including making sure to install smoke alarms in
- 6 required places in their homes.
- 7 WHEREAS, Fires exist as a serious safety concern, both
- 8 locally and nationally; and
- 9 WHEREAS, People face the greatest risk of fire in their
- 10 homes; and
- 11 WHEREAS, Each year, nearly 3,000 people die in house fires in
- 12 the United States, according to the National Fire Protection
- 13 Association (NFPA); and

- 1 WHEREAS, Pennsylvania firefighters and other first responders
- 2 have dedicated their services to prevent the damage,
- 3 destruction, pain and trauma that fires cause families and
- 4 communities through efforts to educate everyone on how to stop
- 5 fires from starting and what protections to follow in case one
- 6 does strike; and
- 7 WHEREAS, The NFPA picked the theme of "Smoke Alarms: A Sound
- 8 You Can Live With" for the 2010 National Fire Prevention Week to
- 9 educate people about the importance of smoke alarms and to
- 10 encourage everyone to take necessary steps to update and
- 11 maintain their home smoke alarm protection; and
- 12 WHEREAS, Efforts to promote the theme provide an ideal
- 13 opportunity to educate the public about smoke alarm
- 14 recommendations and serve as a powerful tool for motivating
- 15 people to install smoke alarms, as needed, and to make sure
- 16 they're working and tested properly; and
- 17 WHEREAS, The NFPA reported the following information on its
- 18 Internet website, www.firepreventionweek.org, regarding the
- 19 importance and use of smoke alarms:
- 20 (1) Smoke alarms cut the risk of dying in a reported
- 21 fire in half.
- 22 (2) Ninety-six percent of homes have at least one smoke
- alarm, according to a 2008 telephone survey.
- 24 (3) Overall, 75% of all United States homes have at
- least one working smoke alarm.
- 26 (4) No smoke alarms were present in 40% of the home fire
- deaths.
- 28 (5) In 23% of the home fire deaths, smoke alarms were
- 29 present but did not sound.
- 30 (6) In more than half of the reported home fires in

- 1 which smoke alarms were present, but did not operate even
- 2 though the fire was large enough, batteries were missing or
- 3 disconnected.
- 4 (7) Nuisance alarms were the leading reason for disconnecting alarms.
- 6 (8) More than half of the smoke alarms found in reported 7 fires and two-thirds of the alarms found in homes with fire 8 deaths were powered by battery only.
- 9 (9) Most homes still have smoke alarms powered by
 10 battery only according to a 2007 American Housing Survey.
- 11 (10) In a 2008 telephone survey, only 12% knew that
 12 smoke alarms should be replaced every 10 years.
- 13 (11) In fires considered large enough to activate a
 14 smoke alarm, hard-wired alarms operated 91% of the time while
 15 battery-powered smoke alarms operated 75% of the time.
- 16 (12) Interconnected smoke alarms on all floors increase 17 safety.
- 18 (13) In a United States Consumer Product Safety
 19 Commission (CPSC) survey of households with any fires,
 20 interconnected smoke alarms were more likely to operate and
 21 alert occupants to a fire, including fires in which the fire
- 22 department was not called;
- 23 therefore be it
- 24 RESOLVED, That the House of Representatives designate the
- 25 month of October 2010 as "Pennsylvania Fire Prevention Month"
- 26 and observe the week of October 3 through 9, 2010, as "National
- 27 Fire Prevention Week" with the theme for each being "Smoke
- 28 Alarms: A Sound You Can Live With"; and be it further
- 29 RESOLVED, That the House of Representatives commend all
- 30 firefighters, other first responders and those who provide

- 1 support to them for all their efforts to prevent, fight and stop
- 2 fires; and be it further
- 3 RESOLVED, That the House of Representatives urge all
- 4 residents, landlords, businesses and other property owners to:
- 5 (1) Ensure all smoke alarms work properly in their
- 6 buildings.
- 7 (2) Change the batteries in the smoke alarms at least
- 8 every six months and replace smoke alarms at least every ten
- 9 years.
- 10 (3) Install interconnected smoke alarms as much as
- 11 possible.
- 12 (4) Ensure that families develop, practice and follow a
- 13 home fire escape plan.
- 14 (5) Visit the Fire Prevention Week website,
- 15 www.firepreventionweek.org, for more fire safety tips.
- 16 (6) Heed the important fire safety messages and support
- 17 the many public safety activities and efforts of
- Pennsylvania's fire and emergency responders.
