AN ACT

1	Authorizing the Commonwealth of Pennsylvania to join the
2	Interstate Compact on Educational Opportunity for Military
3	Children; providing for the form AND ENFORCEMENT of the
4	compact; imposing additional powers and duties on the
5	Governor, the Secretary of the Commonwealth and the compact
6	administrator; and establishing the State Council on
7	Interstate Educational Opportunity for Military Children.
8	The General Assembly of the Commonwealth of Pennsylvania

- o The General Assembly of the Commonwealth of Tenns
- 9 hereby enacts as follows:
- 10 Section 1. Short title.
- 11 This act shall be known and may be cited as the Interstate
- 12 Compact on Educational Opportunity for Military Children Act.
- 13 Section 2. Authority to execute compact.
- 14 The Governor of Pennsylvania, on behalf of this State, is
- 15 hereby authorized to execute a compact in substantially the
- 16 following form with any one or more of the states of the United
- 17 States, and the General Assembly hereby signifies in advance its
- 18 approval and ratification of such compact:
- 19 Interstate Compact on Educational Opportunity

for Military Children

2 ARTICLE I

1

3 PURPOSE

- 4 It is the purpose of this compact to remove barriers to
- 5 educational success imposed on children of military families
- 6 because of frequent moves and deployment of their parents by:
- 7 A. Facilitating the timely enrollment of children of
 8 military families and ensuring that they are not placed
 9 at a disadvantage due to difficulty in the transfer of
- 10 education records from the previous school district(s)
- or variations in entrance/age requirements.
- 12 B. Facilitating the student placement process through which
- children of military families are not disadvantaged by
- variations in attendance requirements, scheduling,
- sequencing, grading, course content or assessment.
- 16 C. Facilitating the qualification and eligibility for
- enrollment, educational programs, and participation in
- 18 extracurricular academic, athletic, and social
- 19 activities.
- 20 D. Facilitating the on-time graduation of children of
- 21 military families.
- 22 E. Providing for the promulgation and enforcement of
- 23 administrative rules implementing the provisions of this
- compact.
- 25 F. Providing for the uniform collection and sharing of
- information between and among member states, schools and
- 27 military families under this compact.
- 28 G. Promoting coordination between this compact and other
- 29 compacts affecting military children.
- 30 H. Promoting flexibility and cooperation between the

- educational system, parents and the student in order to
- 2 achieve educational success for the student.

3 ARTICLE II

4 DEFINITIONS

- 5 As used in this compact, unless the context clearly requires a 6 different construction:
- 7 A. "Active duty" means: full-time duty status in the active
 8 uniformed service of the United States, including members
 9 of the National Guard and Reserve on active duty orders
 10 pursuant to 10 U.S.C. Section 1209 and 121112301 ET SEQ.
 11 AND 12401 ET SEQ.
- B. "Children of military families" means: a school-aged

 child(ren), enrolled in Kindergarten through Twelfth

 (12th) grade, NORMALLY RESIDING in the household of an

 active duty member.
- 16 C. "Compact commissioner" means: the voting representative
 17 of each compacting state appointed pursuant to Article
 18 VIII of this compact.
- D. "Deployment" means: the period one (1) month prior to the service members' departure from their home station on military orders through six (6) months after return to their home station.
- 23 Ε. "Education(al) records" means: those official records, 24 files, and data directly related to a student and 25 maintained by the school or local education agency, 26 including but not limited to records encompassing all the 27 material kept in the student's cumulative folder such as 28 general identifying data, records of attendance and of 29 academic work completed, records of achievement and results of evaluative tests, health data, disciplinary 30

- status, test protocols, and individualized education programs.
- F. "Extracurricular activities" means: a voluntary activity
- 4 sponsored by the school or local education agency or an
- 5 organization sanctioned by the local education agency.
- 6 Extracurricular activities include, but are not limited
- 7 to, preparation for and involvement in public
- 8 performances, contests, athletic competitions,
- 9 demonstrations, displays, and club activities.
- 10 G. "Interstate Commission on Educational Opportunity for
- 11 Military Children" means: the commission that is created
- under Article IX of this compact, which is generally
- referred to as Interstate Commission.
- 14 H. "Local education agency" means: a public authority
- 15 legally constituted by the state as an administrative
- agency to provide control of and direction for
- 17 Kindergarten through Twelfth (12th) grade public
- 18 educational institutions.
- 19 I. "Member state" means: a state that has enacted this
- 20 compact.
- J. "Military installation" means: a base, camp, post,
- station, yard, center, homeport facility for any ship, or
- 23 other activity under the jurisdiction of the Department
- of Defense, including any leased facility, which is
- located within any of the several States, the District of
- 26 Columbia, the Commonwealth of Puerto Rico, the U.S.
- 27 Virgin Islands, Guam, American Samoa, the Northern
- Marianas Islands and any other U.S. Territory. Such term
- does not include any facility used primarily for civil
- 30 works, rivers and harbors projects, or flood control

- 1 projects.
- 2 K. "Non-member state" means: a state that has not enacted this compact.
- L. "Receiving state" means: the state to which a child of a military family is sent, brought, or caused to be sent or brought.
- "Rule" means: a written statement by the Interstate 7 Μ. 8 Commission promulgated pursuant to Article XII of this 9 compact that is of general applicability, implements, 10 interprets or prescribes a policy or provision of the 11 compact, or an organizational, procedural, or practice 12 requirement of the Interstate Commission, and has the 13 force and effect of statutory law in a member state, and 14 includes the amendment, repeal, or suspension of an 15 existing rule.
- N. "Sending state" means: the state from which a child of a military family is sent, brought, or caused to be sent or brought.
- 19 O. "State" means: a state of the United States, the District
 20 of Columbia, the Commonwealth of Puerto Rico, the U.S.
 21 Virgin Islands, Guam, American Samoa, the Northern
 22 Marianas Islands and any other U.S. Territory.
- P. "Student" means: the child of a military family for whom the local education agency receives public funding and who is formally enrolled in Kindergarten through Twelfth (12th) grade.
- 27 Q. "Transition" means: 1) the formal and physical process of 28 transferring from school to school or 2) the period of 29 time in which a student moves from one school in the 30 sending state to another school in the receiving state.

- 1 R. "Uniformed service(s)" means: the Army, Navy, Air Force,
- 2 Marine Corps, Coast Guard as well as the Commissioned
- 3 Corps of the National Oceanic and Atmospheric
- 4 Administration, and Public Health Services.
- 5 S. "Veteran" means: a person who served in the uniformed services and who was discharged or released therefrom
- 7 under conditions other than dishonorable.

8 ARTICLE III

9 APPLICABILITY

- 1. active duty members of the uniformed services as

 defined in this compact, including members of the

 National Guard and Reserve on active duty orders

 pursuant to 10 U.S.C. Section 1209 and 1211;
 - 2. members or veterans of the uniformed services who are severely injured and medically discharged or retired for a period of one (1) year after medical discharge or retirement; and
 - 3. members of the uniformed services who die on active duty or as a result of injuries sustained on active duty for a period of one (1) year after death.
- B. The provisions of this interstate compact shall only apply to local education agencies as defined in this compact.
- C. The provisions of this compact shall not apply to the children of:
- 1. inactive members of the national guard and military reserves;

- members of the uniformed services now retired,
 except as provided in Section A;
 - 3. veterans of the uniformed services, except as provided in Section A; and
 - 4. other U.S. Dept. of Defense personnel and other federal agency civilian and contract employees not defined as active duty members of the uniformed services.

ARTICLE IV

EDUCATIONAL RECORDS & ENROLLMENT

- Unofficial or "hand-carried" education records In the 11 Α. 12 event that official education records cannot be released 13 to the parents for the purpose of transfer, the 14 custodian of the records in the sending state shall 15 prepare and furnish to the parent a complete set of unofficial educational records containing uniform 16 17 information as determined by the Interstate Commission. 18 Upon receipt of the unofficial education records by a 19 school in the receiving state, the school shall enroll 20 and appropriately place the student based on the 21 information provided in the unofficial records pending 22 validation by the official records, as quickly as 23 possible.
- B. Official education records/transcripts Simultaneous
 with the enrollment and conditional placement of the
 student, the school in the receiving state shall request
 the student's official education record from the school
 in the sending state. Upon receipt of this request, the
 school in the sending state will process and furnish the
 official education records to the school in the

- receiving state within ten (10) days or within such time
 as is reasonably determined under the rules promulgated
 by the Interstate Commission.
 - C. Immunizations Compacting states shall give thirty (30) days from the date of enrollment or within such time as is reasonably determined under the rules promulgated by the Interstate Commission, for students to obtain any immunization(s) required by the receiving state. For a series of immunizations, initial vaccinations must be obtained within thirty (30) days or within such time as is reasonably determined under the rules promulgated by the Interstate Commission.
- Kindergarten and First grade entrance age Students 13 D. 14 shall be allowed to continue their enrollment at grade 15 level in the receiving state commensurate with their 16 grade level (including Kindergarten) from a local 17 education agency in the sending state at the time of 18 transition, regardless of MINIMUM age. A student that 19 has satisfactorily completed the prerequisite grade 20 level in the local education agency in the sending state 21 shall be eligible for enrollment in the next highest 22 grade level in the receiving state, regardless of 23 MINIMUM age. A student transferring after the start of 24 the school year in the receiving state shall enter the 25 school in the receiving state on their validated level 26 from an accredited schoolA LOCAL EDUCATION AGENCY in the 27 sending state.

28 ARTICLE V

29 PLACEMENT & ATTENDANCE

30 A. Course placement - When the student transfers before or

2 initially honor placement of the student in educational 3 courses based on the student's enrollment in the sending state school and/or educational assessments conducted at 4 5 the school in the sending state if the courses are offered. Course placement includes but is not limited to 6 7 Honors, International Baccalaureate, Advanced Placement, 8 vocational, technical and career pathways courses. 9 Continuing the student's academic program from the 10 previous school and promoting placement in academically

during the school year, the receiving state school shall

and career challenging courses should be paramount when

considering placement. This does not preclude the school

in the receiving state from performing subsequent

evaluations to ensure appropriate placement and continued

enrollment of the student in the course(s).

B. Educational program placement - The receiving state school shall initially honor placement of the student in educational programs based on current educational assessments conducted at the school in the sending state or participation/placement in like programs in the sending state. Such programs include, but are not limited to: 1) gifted and talented programs; and 2) English as a second language (ESL). This does not preclude the school in the receiving state from performing subsequent evaluations to ensure appropriate placement of the student.

C. Special education services - 1) In compliance with the federal requirements of the Individuals with Disabilities Education Act (IDEA), 20 U.S.C.A. Section 1400 et seq, the receiving state shall initially provide comparable

1 services to a student with disabilities based on his/her 2 current Individualized Education Program (IEP); and 2) In 3 compliance with the requirements of Section 504 of the Rehabilitation Act, 29 U.S.C.A. Section 794, and with 4 5 Title II of the Americans with Disabilities Act, 42 U.S.C.A. Sections 12131-12165, the receiving state shall 6 make reasonable accommodations and modifications to 7 8 address the needs of incoming students with disabilities, 9 subject to an existing 504 or Title II Plan, to provide 10 the student with equal access to education. This does not preclude the school in the receiving state from 11 12 performing subsequent evaluations to ensure appropriate 13 placement of the student.

- D. Placement flexibility Local education agency administrative officials shall have flexibility in waiving course/program prerequisites, or other preconditions for placement in courses/programs offered under the jurisdiction of the local education agency.
- 19 Ε. Absence as related to deployment activities - A student 20 whose parent or legal quardian is an active duty member 21 of the uniformed services, as defined by the compact, and 22 has been called to duty for, is on leave from, or 23 immediately returned from deployment to a combat zone or 24 combat support posting, shall be granted additional 25 excused absences at the discretion of the local education 26 agency superintendent to visit with his or her parent or 27 legal guardian relative to such leave or deployment of 28 the parent or guardian.
- 29 ARTICLE VI
- 30 ELIGIBILITY

1. Special power of attorney, relative to the

guardianship of a child of a military family and

executed under applicable law shall be sufficient

for the purposes of enrollment and all other

actions requiring parental participation and

consent.

- 2. A local education agency shall be prohibited from charging local tuition to a transitioning military child placed in the care of a non-custodial parent or other person standing in locoparentis who lives in a jurisdiction other than that of the custodial parent.
- 3. A transitioning military child, placed in the care of a non-custodial parent or other person standing in loco parentis who lives in a jurisdiction other than that of the custodial parent, may continue to attend the school in which he/she was enrolled while residing with the custodial parent.
- ELIGIBILITY FOR ENROLLMENT CHILDREN OF MILITARY Α. FAMILIES SHALL BE ELIGIBLE FOR ENROLLMENT IN THE PUBLIC SCHOOLS OF A STATE PURSUANT TO THE PROVISIONS OF THE STATE'S PUBLIC SCHOOL LEGISLATION THAT PROVIDE FOR ADMISSION, WITHOUT THE PAYMENT OF TUITION, OF CHILDREN OF MILITARY FAMILIES NOT DOMICILED WITHIN THE SCHOOL DISTRICT, PROVIDED THAT THE SPECIFIED CONDITIONS IN THOSE PROVISIONS ARE MET.
 - B. Eligibility for extracurricular participation State and local education agencies shall facilitate the opportunity

- for transitioning military children's inclusion in
- 2 extracurricular activities, regardless of application
- deadlines, to the extent they are otherwise qualified.
- 4 ARTICLE VII
- 5 GRADUATION
- 6 In order to facilitate the on-time graduation of children of
- 7 military families states and local education agencies shall
- 8 incorporate the following procedures:
- 9 A. Waiver requirements Local education agency
- 10 administrative officials shall waive specific courses
- 11 required for graduation if similar course work has been
- satisfactorily completed in another local education
- agency or shall provide reasonable justification for
- denial. Should a waiver not be granted to a student who
- would qualify to graduate from the sending school, the
- local education agency shall provide an alternative means
- of acquiring required coursework so that graduation may
- 18 occur on time.
- 19 B. Exit exams States shall accept: 1) exit or end-of-
- 20 course exams required for graduation from the sending
- 21 state; or 2) national norm-referenced achievement tests
- or 3) alternative testing, in lieu of testing
- 23 requirements for graduation in the receiving state. In
- the event the above alternatives cannot be accommodated
- by the receiving state for a student transferring in his
- or her Senior year, then the provisions of Article VII,
- 27 Section C shall apply.
- 28 C. Transfers during Senior year Should a military student
- transferring at the beginning or during his or her Senior
- 30 year be ineligible to graduate from the receiving local

education agency after all alternatives have been considered, the sending and receiving local education agencies shall ensure the receipt of a diploma from the sending local education agency, if the student meets the graduation requirements of the sending local education agency. In the event that one of the states in question is not a member of this compact, the member state shall use best efforts to facilitate the on-time graduation of the student in accordance with Sections A and B of this Article.

ARTICLE VIII

STATE COORDINATION

Α. Each member state shall, through the creation of a State Council or use of an existing body or board, provide for the coordination among its agencies of government, local education agencies and military installations concerning the state's participation in, and compliance with, this compact and Interstate Commission activities. While each member state may determine the membership of its own State Council, its membership must include at least: the state superintendent of education, superintendent of a school district with a high concentration of military children, representative from a military installation, one representative each from the legislative and executive branches of government, and other offices and stakeholder groups the State Council deems appropriate. A member state that does not have a school district deemed to contain a high concentration of military children may appoint a superintendent from another school district to represent local education agencies on the State Council.

- 1 B. The State Council of each member state shall appoint or
- 2 designate a military family education liaison to assist
- 3 military families and the state in facilitating the
- 4 implementation of this compact.
- 5 C. The compact commissioner responsible for the
- 6 administration and management of the state's
- 7 participation in the compact shall be appointed by the
- 8 Governor or as otherwise determined by each member state.
- 9 D. The compact commissioner and the military family
- 10 education liaison designated herein shall be ex-officio
- 11 members of the State Council, unless either is already a
- 12 full voting member of the State Council.
- 13 ARTICLE IX
- 14 INTERSTATE COMMISSION ON EDUCATIONAL
- 15 OPPORTUNITY FOR MILITARY CHILDREN
- 16 The member states hereby create the "Interstate Commission on
- 17 Educational Opportunity for Military Children." The activities
- 18 of the Interstate Commission are the formation of public policy
- 19 and are a discretionary state function. The Interstate
- 20 Commission shall:
- 21 A. Be a body corporate and joint agency of the member states
- and shall have all the responsibilities, powers and
- 23 duties set forth herein, and such additional powers as
- 24 may be conferred upon it by a subsequent concurrent
- action of the respective legislatures of the member
- 26 states in accordance with the terms of this compact.
- 27 B. Consist of one Interstate Commission voting
- representative from each member state who shall be that
- 29 state's compact commissioner.
- 30 1. Each member state represented at a meeting of the

1 Interstate Commission is entitled to one vote.

2. A majority of the total member states shall constitute a quorum for the transaction of business, unless a larger quorum is required by the bylaws of the Interstate Commission.

- 3. A representative shall not delegate a vote to another member state. In the event the compact commissioner is unable to attend a meeting of the Interstate Commission, the Governor or State Council may delegate voting authority to another person from their state for a specified meeting.
- 4. The bylaws may provide for meetings of the
 Interstate Commission to be conducted by
 telecommunication or electronic communication.
- C. Consist of ex-officio, non-voting representatives who are members of interested organizations. Such ex-officio members, as defined in the bylaws, may include but not be limited to, members of the representative organizations of military family advocates, local education agency officials, parent and teacher groups, the U.S. Department of Defense, the Education Commission of the States, the Interstate Agreement on the Qualification of Educational Personnel and other interstate compacts affecting the education of children of military members.
- D. Meet at least once each calendar year. The chairperson may call additional meetings and, upon the request of a simple majority of the member states, shall call additional meetings.
- 29 E. Establish an executive committee, whose members shall include the officers of the Interstate Commission and

1 such other members of the Interstate Commission as 2 determined by the bylaws. Members of the executive 3 committee shall serve a one year term. Members of the executive committee shall be entitled to one vote each. 4 5 The executive committee shall have the power to act on behalf of the Interstate Commission, with the exception 6 7 of rulemaking, during periods when the Interstate 8 Commission is not in session. The executive committee 9 shall oversee the day-to-day activities of the 10 administration of the compact including enforcement and 11 compliance with the provisions of the compact, its bylaws 12 and rules, and other such duties as deemed necessary. The 13 U.S. Dept. of Defense shall serve as an ex-officio, 14 nonvoting member of the executive committee.

- F. Establish bylaws and rules that provide for conditions and procedures under which the Interstate Commission shall make its information and official records available to the public for inspection or copying. The Interstate Commission may exempt from disclosure information or official records to the extent they would adversely affect personal privacy rights or proprietary interests.
- 23 CommissionGIVE PUBLIC NOTICE of all meetings and all
 24 meetings shall be open to the public, except as set forth
 25 in the rules or as otherwise provided in the compact. The
 26 Interstate Commission and its committees may close a
 27 meeting, or portion thereof, where it determines by two28 thirds vote that an open meeting would be likely to:
 - 1. Relate solely to the Interstate Commission's internal personnel practices and procedures;

- Disclose matters specifically exempted from
 disclosure by federal and state statute;
 - 3. Disclose trade secrets or commercial or financial information which is privileged or confidential;
 - 4. Involve accusing a person of a crime, or formally censuring a person;
 - 5. Disclose information of a personal nature where disclosure would constitute a clearly unwarranted invasion of personal privacy;
 - 6. Disclose investigative records compiled for law enforcement purposes; or
 - 7. Specifically relate to the Interstate

 Commission's participation in a civil action or other legal proceeding.
- 15 Η. For a meeting, or portion of a meeting, closed pursuant 16 to this provision, the Interstate Commission's legal counsel or designee shall certify that the meeting may be 17 18 closed and shall reference each relevant exemptible 19 provision CAUSE ITS LEGAL COUNSEL OR DESIGNEE TO CERTIFY 20 THAT A MEETING MAY BE CLOSED AND SHALL REFERENCE EACH RELEVANT EXEMPTIBLE PROVISION FOR ANY MEETING, OR PORTION 21 22 OF A MEETING, WHICH IS CLOSED PURSUANT TO THIS PROVISION. 23 The Interstate Commission shall keep minutes which shall 24 fully and clearly describe all matters discussed in a 25 meeting and shall provide a full and accurate summary of 26 actions taken, and the reasons therefore, including a 27 description of the views expressed and the record of a roll call vote. All documents considered in connection 28 29 with an action shall be identified in such minutes. All

minutes and documents of a closed meeting shall remain

under seal, subject to release by a majority vote of the Interstate Commission.

- The Interstate Commission shall collectCOLLECT 3 I. standardized data concerning the educational transition 4 of the children of military families under this compact 5 as directed through its rules which shall specify the 6 7 data to be collected, the means of collection and data 8 exchange and reporting requirements. Such methods of data 9 collection, exchange and reporting shall, in so far as is reasonably possible, conform to current technology and 10 coordinate its information functions with the appropriate 11 12 custodian of records as identified in the bylaws and 13 rules.
- 14 J. The Interstate Commission shall create CREATE a process that permits military officials, education officials and 15 16 parents to inform the Interstate Commission if and when 17 there are alleged violations of the compact or its rules 18 or when issues subject to the jurisdiction of the compact 19 or its rules are not addressed by the state or local 20 education agency. This section shall not be construed to 21 create a private right of action against the Interstate 22 Commission or any member state OR A POLITICAL SUBDIVISION 23 OF A MEMBER STATE.

24 ARTICLE X

- 25 POWERS AND DUTIES OF THE INTERSTATE COMMISSION
- 26 The Interstate Commission shall have the following powers:
- 27 A. To provide for dispute resolution among member states.
- B. To promulgate rules and take necessary actions to effect the goals, purposes and obligations as enumerated in this compact. The rules shall have the force and effect of

- 1 statutory law and shall be binding in the compact states
- 2 to the extent and in the manner provided in this compact.
- 3 C. To issue, upon request of a member state, advisory
- 4 opinions concerning the meaning or interpretation of the
- 5 interstate compact, its bylaws, rules and actions.
- 6 D. To enforce compliance with the compact provisions, the
- 7 rules promulgated by the Interstate Commission, and the
- bylaws, using all necessary and proper means, including
- 9 but not limited to the use of judicial process.
- 10 E. To establish and maintain offices which shall be located
- within one or more of the member states.
- 12 F. To purchase and maintain insurance and bonds.
- 13 G. To borrow, accept, hire or contract for services of
- 14 personnel.
- 15 H. To establish and appoint committees including, but not
- limited to, an executive committee as required by Article
- 17 IX, Section E, which shall have the power to act on
- 18 behalf of the Interstate Commission in carrying out its
- 19 powers and duties hereunder.
- 20 I. To elect or appoint such officers, attorneys, employees,
- 21 agents, or consultants, and to fix their compensation,
- 22 define their duties and determine their qualifications;
- and to establish the Interstate Commission's personnel
- 24 policies and programs relating to conflicts of interest,
- rates of compensation, and qualifications of personnel.
- 26 J. To accept any and all donations and grants of money,
- 27 equipment, supplies, materials, and services, and to
- 28 receive, utilize, and dispose of it.
- 29 K. To lease, purchase, accept contributions or donations of,
- or otherwise to own, hold, improve or use any property,

- 1 real, personal, or mixed.
- 2 L. To sell, convey, mortgage, pledge, lease, exchange,
- 3 abandon, or otherwise dispose of any property, real,
- 4 personal or mixed.
- 5 M. To establish a budget and make expenditures.
- N. To adopt a seal and bylaws governing the management and operation of the Interstate Commission.

The executive director shall hire and supervise such other persons as may be authorized by the Interstate Commission.

The Interstate Commission's executive director and employees shall be immune from suit and liability, either personally or in their official capacity, for a claim for damage to or loss of property or personal injury or other civil liability caused or arising out of or relating to an actual or alleged act, error, or omission that occurred, or that such person had a reasonable basis for believing occurred, within the scope of Interstate Commission employment, duties, or responsibilities; provided, that such person shall not be protected from suit or liability for damage, loss, injury, or liability caused by the intentional or willful and wanton misconduct of such person.

 - 2. Provide remedial training and specific technical assistance regarding the default.
 - 3. If the defaulting state fails to cure the default, the defaulting state shall be terminated from the compact upon an affirmative vote of a majority of the member states and all rights, privileges and benefits conferred by this compact

shall be terminated from the effective date of termination. A cure of the default does not relieve the offending state of obligations or liabilities incurred during the period of the default.

- 4. Suspension or termination of membership in the compact shall be imposed only after all other means of securing compliance have been exhausted. Notice of intent to suspend or terminate shall be given by the Interstate Commission to the Governor, the majority and minority leaders of the defaulting state's legislature, and each of the member states.
- 5. The state which has been suspended or terminated is responsible for all assessments, obligations and liabilities incurred through the effective date of suspension or termination including obligations, the performance of which extends beyond the effective date of suspension or termination.
- 6. The Interstate Commission shall not bear any costs relating to any state that has been found to be in default or which has been suspended or terminated from the compact, unless otherwise mutually agreed upon in writing between the Interstate Commission and the defaulting state.
- 7. The defaulting state may appeal the action of the Interstate Commission by petitioning the U.S.

 District Court for the District of Columbia or the federal district where the Interstate
