AN ACT

- 1 Amending Title 75 (Vehicles) of the Pennsylvania Consolidated
- Statutes, further providing for homicide by vehicle while
- 3 driving under influence.
- 4 The General Assembly of the Commonwealth of Pennsylvania
- 5 hereby enacts as follows:
- 6 Section 1. Section 3735 of Title 75 of the Pennsylvania
- 7 Consolidated Statutes is amended to read:
- 8 § 3735. Homicide by vehicle while driving under influence.
- 9 (a) Offense defined. -- Any person who unintentionally causes
- 10 the death of another person as the result of a violation of
- 11 section 3802 (relating to driving under influence of alcohol or
- 12 controlled substance) and who is convicted of violating section
- 13 3802 is guilty of a felony of the second degree when the
- 14 violation is the cause of death and the sentencing court shall
- 15 order the person to serve a minimum term of imprisonment [of not
- 16 less than three years. A consecutive] as provided for in
- 17 <u>subsection (a.1). An additional</u> three-year term of imprisonment
- 18 shall be imposed for each victim whose death is the result of
- 19 the violation of section 3802.

- 1 (a.1) Sentences imposed under subsection (a).--Sentences
- 2 imposed under subsection (a) shall be determined according to
- 3 blood alcohol content in the following manner:
- 4 (1) Persons with a blood alcohol content between 0.08%
- and 0.10% at the time of the offense who are sentenced under
- 6 <u>subsection (a) shall serve a minimum term of imprisonment of</u>
- 7 <u>not less than three years.</u>
- 8 (2) Persons with a blood alcohol content between 0.10%
- 9 and 0.16% at the time of the offense who are sentenced under
- 10 <u>subsection (a) shall serve a minimum term of imprisonment of</u>
- 11 <u>not less than six years.</u>
- 12 (3) Persons with a blood alcohol content between 0.16%
- and 0.20% at the time of the offense who are sentenced under
- 14 <u>subsection (a) shall serve a minimum term of imprisonment of</u>
- 15 <u>not less than nine years.</u>
- 16 (4) Persons with a blood alcohol content between 0.20%
- and 0.25% at the time of the offense who are sentenced under
- 18 subsection (a) shall serve a minimum term of imprisonment of
- not less than 12 years, and the offense shall be a felony of
- 20 the first degree.
- 21 (5) Persons with a blood alcohol content of 0.25% or
- higher at the time of the offense who are sentenced under
- subsection (a) shall serve a minimum term of imprisonment of
- not less than 15 years, and the offense shall be a felony of
- 25 the first degree.
- 26 (b) Applicability of sentencing quidelines. -- The sentencing
- 27 guidelines promulgated by the Pennsylvania Commission on
- 28 Sentencing shall not supersede the mandatory [penalty] penalties
- 29 of this section.
- 30 Section 2. This act shall take effect in 60 days.
